- This form should be used to register the source of seed used on your HLS agreement.
- British native-origin seed refers to seed originally collected from wild populations in Great Britain (from sites with no known history of sowing of amenity or agricultural varieties) and either sown directly, or grown on as a field crop to provide further seed. It includes seed collected in 'green hay'. It excludes certified amenity or agricultural varieties of native species.
- **Organic farmers should source native seed from an organic source, if one is available. If not, they should contact their Organic Inspection Body to discuss whether an alternative source requires a derogation.** Please read the OELS and HLS scheme handbooks and supplements (if any) for more information on the use of native seed mixes.
- HLS agreement holders must complete this form when claiming payment for native seed capital items. Your HLS claim cannot be paid until this form has been received.
- Please write clearly in **black ink** and BLOCK letters. Any alterations must be initialled and dated. Do **NOT** use correction fluid.
