The **Commonwealth Scholarship Commission in the United Kingdom** (CSC) is responsible for managing Britain's contribution to the Commonwealth Scholarship and Fellowship Plan (CSFP).

The CSC supports over 800 scholarships and fellowships for postgraduate study and professional development each year. Awards are funded by the Department for International Development (for developing Commonwealth countries), and the Department for Business, Innovation and Skills and the Scottish Government (for developed Commonwealth countries), in conjunction with UK universities. The CSC also nominates UK citizens for scholarships to study in other Commonwealth countries under the CSFP.

The CSC makes available seven types of award:

Commonwealth Scholarships for PhD research/Master's study – available for postgraduate study at any UK university which has a funding agreement with the CSC. Candidates should apply in the first instance to the national nominating agency of their resident country. Additional nominations are sought each year from developing country universities and other sources.

Commonwealth Shared Scholarships – for developing country students who would not otherwise be able to undertake Master's-level study in the UK, jointly supported by UK universities. Individual universities are invited each year to bid for such awards, and candidates should apply directly to the institutions.

Commonwealth Academic Fellowships – aimed at mid-career staff in developing country universities, providing for three months' work at a UK institution. Nominations are invited directly from the universities and the countries concerned.

Commonwealth Split-site Scholarships – to support PhD candidates to spend up to one year in the UK as part of their doctoral studies. Nominations for awards are accepted from national nominating agencies and developing country universities.

Commonwealth Professional Fellowships – offering mid-career professionals from developing countries the opportunity to spend a period (typically three months) with a UK host organisation working in a relevant field. Applications are invited each year from UK organisations that wish to host such awards – these can be from any sector, although the recipients of awards must not hold a full-time academic position.

Commonwealth Distance Learning Scholarships – enabling developing country students to study UK Master's degree courses while living in their home countries. The scholarships are only available for specific courses selected by the CSC on the basis of their quality and relevance to development. UK universities are invited to register expressions of interest for the CSC to support their course(s) each year.

The CSC was established by Act of Parliament in 1959, and is a non-departmental public body in its own right. The CSC's Secretariat is provided by the Association of Commonwealth Universities; overseas services are provided by the British Council.

The CSC is part of a larger Commonwealth-wide scheme: the Commonwealth Scholarship and Fellowship Plan (CSFP). The CSFP is an international programme under which member governments offer scholarships and fellowships to citizens of other Commonwealth countries. It was established at the first Commonwealth education conference in 1959 and is reviewed by Commonwealth education ministers at their triennial meetings. The CSFP has enabled almost 30,000 individuals to study in over 20 countries across the Commonwealth.

Foreword

We have the honour to submit, pursuant to Schedule 2, Section 13, Clause (5) 2 of the International Development Act 2002, the following report of the Commonwealth Scholarship Commission in the United Kingdom for the year ending 30 September 2013.

In a period of austerity, public expenditure of any description is subject to increased scrutiny. The provision of international scholarships is no exception. In the past year, the work of the Commonwealth Scholarship Commission (CSC) has been subject to substantial review, both internally and externally. We are delighted to report that the results of this have been almost uniformly positive.

In common with all non-departmental public bodies (NDPBs), the role of the CSC is routinely reviewed every three years. Our triennial review, conducted during the year under report, clearly confirmed the findings of the previous exercise, in 2010, that both the function and NDPB role remain appropriate. There have been positive comments from the two Parliamentary Select Committees that looked at our work, and it was also encouraging to see the increased profile given to Commonwealth Scholarships by the Department for Business, Innovation and Skills in its international strategy, produced towards the end of the year.

The comments of the Commons Science and Technology Committee, published in November 2012, gave most cause for satisfaction, because the Committee had actually taken the time to meet with a group of our students face-to-face. Their ultimate conclusion that 'DFID's support for individuals through the Commonwealth Scholarship Commission (CSC) has been hugely important' reinforces our own experience that the best justification for our work remains the achievements of our highly intelligent, articulate, and ambitious award holders, focused on aiding the development of their own countries.

The number of these award holders has risen since the last report. New awards have increased from 737 in 2011 to 853 in 2012; the number of those on award from 1,386 to 1,495. This increase reflects a rise in our grant from the Department for International Development, and the continued support of the Department for Business, Innovation and Skills and the Scottish Government. We also benefit from the considerable work of nominating agencies in every Commonwealth country, some 200 academic advisers in the United Kingdom (all of whom provide their time for free), and UK universities, who provide significant fee reductions in support of our work. To all of these, we would like to express our grateful thanks.

The increase in numbers of Commonwealth Scholars and Fellows also reflects streamlining on the part of the CSC itself. In April 2013, we introduced the biggest rationalisation of our administration for 50 years, bringing all our UK management under the heading of the Secretariat at the Association of Commonwealth Universities, whilst focusing the work of the British Council on our alumni and other activities overseas. As a result, the proportion of our funds devoted to administration has reduced to 7.7% in 2012-2013, from 9.4% in 2011-2012. In 2013-2014, when the full impact of the changes will be felt, we anticipate a further reduction.

Our greatest satisfaction, however, remains the impact that our award holders and alumni have on their countries and the wider world. Our Evaluation Programme continues to provide evidence of this. During the report year, we published reports on impact in environmental sustainability and the impact of Master's scholarships, and we are currently developing a long-term study matching successful and unsuccessful candidates to help assess the difference that Commonwealth Scholarships make.

In the meantime, there is no shortage of individual success stories. Commonwealth Scholars continue to thrive in leadership roles across the world: examples include Mark Carney who, as Governor of the Bank of England, is the most high-profile recent central bank appointment among our alumni; and George Brandis, Attorney-General of Australia and the latest alumnus to reach a cabinet position. Equally important are those who report a major impact on development, such as Oluwatoyin Opaoye, Head of Health Programmes for the Leah Charity Foundation in Nigeria, which delivers essential health services to rural areas via mobile clinics; and Simon Daffi Kirway, whose work focuses on improving girls' access to education in 44 secondary schools across Tanzania. These examples are the tip of a very big iceberg.

To all of the above, together with our fellow Commissioners and staff in the Secretariat and the British Council, without whom Commonwealth Scholarships could not operate at their present level, we would like to extend our grateful thanks.

Monitoring progress

The CSC places great emphasis on monitoring and evaluation, as part of its responsibility to both funding bodies and award holders. This is reflected in the programmes and procedures established to assess both the progress of Commonwealth Scholars and Fellows and that of the scheme as a whole.

Maintaining contact with award holders

Each award holder is the responsibility of a named officer within the Secretariat (based at the Association of Commonwealth Universities) who, from the point of provisional selection, becomes the main point of contact for subsequent dealings with the CSC.

Monitoring progress of award holders

- If necessary, contact is made with the prospective supervisor at the time of arrival, pointing out special needs and problems that may be encountered.
- Award holders and, for research degrees, supervisors are required to write a report at the end of their first term, enabling potential problems to be highlighted at an early stage.
- Award holders and their supervisors/tutors are required to write a detailed report at the end of each year.
- First term and annual reports are monitored for emerging issues – each annual report is read not only by Secretariat staff, but also by at least one member of the Commission.

Evaluating the scheme and new programmes

- The CSC Evaluation and Monitoring Programme is responsible for the acquisition and analysis of data relating to the outcomes and impact of the CSC's scholarship and fellowship schemes. During this report year, new tools, methods and processes were introduced, including a counterfactual study, the distribution of an improved alumni evaluation survey, and engagement with other stakeholders, such as host organisations. As well as an externally-commissioned report looking at how value for money might be measured, two evaluation reports were completed. The first covered impact in environmental sustainability, and the second examined the impact of the three types of awards offered for Master's study. A third report, on the Professional Fellowships scheme, was near completion at the end of the report year.
- Host institutions are systematically surveyed each year to obtain information on progress, qualifications gained, submission dates, and, where studies are still in progress, likely dates of completion (see 'Completion of courses' on right). The Secretariat compares performance by gender and subject and across institutions.
- Each year, the Secretariat administers an anonymous survey of award holders, enquiring about their experiences of studying and living in the UK and the administration of the scheme. These responses are analysed for review by the CSC (see 'Award holders' views' on right).
- Feedback is sought from delegates at the CSC's Welcome Programme and other student events.

Secretariat staff make contact with award holders shortly after arrival in the UK to check that all is well, and communicate with award holders at regular intervals throughout the year. In addition, Secretariat staff visit a number of institutions each year, meeting with award holders and their supervisors to listen to issues and provide information and advice. Access, as required, is provided by the Secretariat to specialist services for matters such as welfare and immigration.

The British Council provides pre-departure support, including useful information for award holders to assist them in their preparations for, their journey to, and their stay in the UK.

Approval was given during the report year to develop a more comprehensive student engagement strategy. Key features of this strategy include regular newsletters, a programme of events, and the Development Module, which is designed to improve the development impact of the scholarship programme and was piloted during the report year.

Completion of courses

The successful completion of qualifications is monitored closely by the CSC. For taught Master's courses, the success rate is consistently over 90%, and the composite completion rate for those starting their awards during the five-year period 2006-2010 is 97%. For Commonwealth Shared Scholars, the composite rate for 2006-2010 is reported at 95%.

Doctoral completion rates also continue to be high, with that for the most recent year analysed – PhDs started in 2007 – at 85%, and the composite completion rate figure for 2003-2007 at 88%. The submission rate (those who submitted their thesis with four years of commencing their PhD) for Commonwealth Scholars commencing in 2007 is 69%. With some data from this cohort still to be reported, this figure is expected to rise; the submission rate excluding these outstanding results is 77%.

Award holders' views

In 2013, 415 award holders returned the annual anonymous questionnaire. This questionnaire asks award holders to rate various aspects of their experience on a five-point scale, ranging from 'excellent' through to 'very poor', which enables us to compare responses from year to year. Respondents continue to rate the ACU's overall

administration of the scheme highly, with 92% rating it as 'excellent' or 'good'. New award holders were asked to rate the ACU's administration of their selection and placement at a UK institution; 91% rated it as 'excellent' or 'good' (see Table 1).

Regarding respondents' institutions of study, 'excellent' or 'good' ratings for supervision/teaching, facilities and resources, and the overall academic experience were all at least 90%. The combined 'excellent' and 'good' rating for institutions' provision of welfare advice has continued to increase, and this year sees the highest rating in recent years at 77% (see Table 2).

In addition to this quantitative data, the anonymous questionnaire also gives award holders the opportunity to comment at greater length on their award and their experience in the UK. Positive aspects of respondents' time on award included good relationships with supervisors and fellow students/colleagues, access to facilities and resources not available elsewhere, the opportunities to develop skills and networks, and the contribution they make to their field of research. In addition to these academic matters, respondents valued the opportunity to experience not only British culture, but also a diverse and multicultural environment where they could gain different perspectives on life and work. There was appreciation for transport and health systems and reliable internet access. However, some reported experiencing problems with homesickness and adjusting to aspects of life in the UK such as the weather and culture. The cost of living and the struggle to find suitable and affordable accommodation were mentioned, as well as the pressures involved in completing work within the award tenure. Regarding how their experiences could have been improved, respondents typically mentioned more time on award, increased stipend and resources, more specific advance information about the area of the UK in which they will be residing and working, and more opportunities to meet other award holders.

Following the established schedule for review, an independent review of cross-government scholarship provision will take place in late 2013/early 2014. Regarding feedback on current stipend rates, in additional questions not shown in Tables 1 and 2, 77% of respondents felt that the stipend was at least 'fairly adequate'. Stipend rates tend to be an area of concern for questionnaire respondents, but levels of satisfaction have gradually risen over recent years; 75% described their allowances as at least 'fairly adequate' in 2012, compared with 76% in 2011, 73% in 2010, 68% in 2009, and 65% in 2008. In the accompanying comments, some respondents described being able to manage adequately, but that additional and unforeseen costs could be a problem. Some respondents were living in more expensive areas or had difficulty securing affordable accommodation, and those with families also found it harder to manage.

Despite these concerns, out of those award holders nearing the end of their award, 92% (of the 268 responding to this particular question) felt that their academic programme had 'completely' or 'mostly' fulfilled the purpose for which they came to the UK.

2012 awards

In addition to the sections of this report that present the total numbers of awards held in 2012-2013, we also present numbers of new awards taken up in 2012-2013 (referred to as 'New awards 2012'). During the report year, a number of meetings took place to select the 2013 intake; these will be reported as new awards for 2013 in the next Annual Report for the year ending 30 September 2014.

1,495 awards were held in the 2012-2013 report year. 853 of these were new 2012 awards taken up, representing the intake for the second year of the 2011-2015 funding period. A breakdown of these new and on award figures can be seen in Tables 3, 4 and 5.

For this round of selections, a higher number of invitations to nominate were issued, reflecting the increased budget available. 907 nominations were received for DFID-funded awards (excluding Distance Learning Scholarships and Shared Scholarships), which is a considerable increase compared with previous years – 763 were received in 2011, and 832 in 2010. From these 907 nominations, 522 selections were made (excluding Distance Learning and Shared Scholarships), again a higher number than previous years – 421 in 2011 and 414 in 2010. The proportion of selections from eligible nominations this year is 58%. Increased numbers of awards taken up in 2012 compared with 2011 can be seen in Table 5.

UK universities directly recruit and select Shared Scholarship and Distance Learning Scholarship candidates, whose awards are confirmed by the CSC's selection committees. For Shared Scholarships, universities approved applications from 323 candidates and the CSC selected 215 candidates for a take-up of 188 awards (in the previous year, applications from 285 candidates were approved and 182 were selected for a take-up of 158 awards). For Distance Learning Scholarships, universities approved 346 applications and the CSC made 236 selections (equivalent figures in the previous year are 281 applications and 213 selections). Both these schemes also had increased numbers of selections this year.

There were also 11 selections for awards for doctoral study funded by BIS and the Scottish Government, out of 67 nominations. 9 candidates took up awards, and a similar-sized programme will run in 2013. Funding for this scheme is available until 2015.

It should be emphasised that, before nomination to the CSC, most candidates have undergone a highly competitive selection process in their own country.

Region

46 countries were represented in the 2012 intake for Commonwealth Scholarships and Fellowships (see pages 18-20). When selecting candidates, the CSC's primary concern is that successful applicants should be of the highest calibre. As a result, the CSC does not operate specific quotas for individual Commonwealth countries. It does, however, have broad regional selection

targets for those scholarship candidates funded by DFID. For the 2012 intake, targets were broadly met, as can be seen from Table 6, with sub-Saharan Africa taking 54% of the awards, South Asia 34%, and the remaining small states (encompassing the Pacific, Caribbean and Southeast Asia) 12%.

Level of study

The CSC continues to aim for a target of 60:40 for taught and research provision for DFID-funded scholarships nominated by national nominating agencies, in order to reflect the increased number of highly relevant and targeted Masters' degrees available, and also to deal with the increasing cost of doctoral scholarships. 65% of selections for 2012 DFID-funded scholarships were for Master's programmes and 35% for doctoral study. Doctoral-level scholarships remain a significant part of the CSC's portfolio of awards, both in traditional and split-site modes, and it is committed to offering these for the foreseeable future. In addition to the DFID-funded scholarships already mentioned and Split-site Scholarships for doctoral study, 78% of scholarships awarded to university staff in developing countries in this report year were for doctoral study.

Gender

This year, the CSC continued to focus on encouraging the participation of women in all its programmes. While positive discrimination is not a factor in selection, the importance of a fair gender balance is highlighted to nominating agencies.

In 2012, 40% of nominations received for all DFID-funded scholarships (including Distance Learning Scholarships and Shared Scholarships) were female candidates. 46% of selected candidates were female.

The proportions of women nominated and selected for Academic Fellowships are typically lower, and in 2012 26% of nominations and 31% of selections were female candidates. For 2012 Professional Fellowships, the proportions increased; women comprised 43% of nominated candidates and 41% of selected candidates.

During the report year, the CSC decided to invite nominations for 2013 awards from women's universities in South Asia and from the Forum for African Women Educationalists, to increase the number of female nominations.

In terms of support on award, provision is made for award holders on longer awards who are accompanied by their families.

The CSFP

As part of the UK's contribution to the Commonwealth Scholarship and Fellowship Plan (CSFP), the CSC also nominates UK candidates for Commonwealth Scholarships offered by other Commonwealth countries. In 2012-2013, a total of 12 award holders from the UK were funded for Master's study in India, doctoral study in New Zealand, and postdoctoral study in Canada, in subjects including Mathematics, Theology, Indian Philosophy and Religion, Criminology, Glaciology, and Oceanography and Marine Biology.

Governance statement

The Commonwealth Scholarship Commission in the United Kingdom (CSC) was established by Act of Parliament in 1959 in order to manage the UK contribution to the Commonwealth Scholarship and Fellowship Plan (CSFP), launched by Commonwealth Education Ministers in 1958. Its status was subsequently reaffirmed in the International Development Act of 2002.

The CSC is a non-departmental public body, for which the Department for International Development (DFID) is the lead department and main sponsor, focusing exclusively on awards that deliver on poverty reduction. However, other financial contributions have been received in recent years from the Department for Business, Innovation and Skills, the Scottish Government, and the Foreign and Commonwealth Office, especially for awards to scholars from richer Commonwealth countries. The CSC is independent of Government in its decision-making and operations, and the Act of Parliament expressly forbids political interference in the selection of individual candidates for scholarships. The CSC submits an Annual Report on its work each year to the Secretary of State; this forms the basis of a report submitted by the Secretary of State to Parliament, to which (s)he is ultimately responsible for the work of the CSC.

In addition to regulations provided in the 1959 Act (which have been confirmed in subsequent Development Acts) and subsequent Ministerial Directives, detailed governance arrangements for the CSC have been set out in a Memorandum of Understanding between the CSC and DFID. The current Memorandum covers the period to March 2014. This will be superseded by a Framework Document that will set out the CSC's three-year corporate and one-year business plans. The DFID Internal Audit Department (IAD) provides the CSC's internal audit function. The CSC's annual income and expenditure are incorporated in the overall accounts of DFID, and the CSC account is held with the Government Banking Service.

The Commission comprises 15 members, including the Chair, who are appointed in line with the principles of the Code of Practice for Ministerial Appointments to Public Bodies. Members are appointed by the Secretary of State for an initial period of three years, with the possibility of renewal for one further three-year appointment. The Executive Secretary of the Commission is the Accounting Officer for the CSC, with responsibility to the Secretary of State for its conduct and performance. It is expected that the Chair and other relevant officials will meet with relevant Ministers at least annually to discuss the work of the CSC.

The full Commission meets three times per year. It is supported in its work by specialist committees, made up of Commissioners, which deal with Finance, Audit and Risk Management, Awards Policy, External Liaison, and Evaluation and Monitoring. Separate committees of Commissioners are convened to handle the selection of scholarship recipients. The CSC has no employees, contracting out its Secretariat and other management functions to two external bodies: the Association of Commonwealth Universities (ACU) and the British Council. The effectiveness and value for money of these arrangements are formally evaluated annually by the Finance Committee, which recommends appropriate action to the full Commission. The CSC operates an Evaluation and Monitoring Programme which provides evidence of the impact of its work, through interviews and surveys of alumni and other stakeholders. The results of this programme influence the CSC's decision-making processes.

The status of the CSC was subject to an independent assessment by DFID in 2013, as part of the Government's rolling programme of triennial review of public bodies. This review reported in September 2013 that the functions carried out by the CSC are required and that the delivery model is appropriate and offers value for money.


