Thank you for your e-mail of 21 October 2014 asking for information about aircraft operated by the UK Armed Forces.

You originally requested the following information:

"Please can you provide me with a full fleet list of all aircraft (fast jets, rotorcraft, cargo planes etc.) operated by the Royal Air Force, Royal Navy and British Army.

Where possible, I'd be grateful for the inclusion of tail codes and current squadrons, in addition to the model / type and serial.

I submitted an FOI recently regarding RAF Typhoon, Hawk and Tornado GR4 aircraft. A response followings its layout would be much appreciated.

Whilst I notice most of your correspondence is sent in PDF format I would be grateful if, where IT systems allow, the full fleet lists could be sent in an Excel Spreadsheet."

Your e-mail of 23 October refined the request to cover Royal Navy (RN) Hawk aircraft and RN and RAF Sea King helicopters only.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held. I attach lists at Annex A to C showing the aircraft type, mark, tail number and where appropriate squadron and tail code. The information provided covers Hawk aircraft operated by the RN and Sea King helicopters operated by either the RN or RAF. For consistency I have used the term "sustainment fleet" for both RN and RAF aircraft.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an

independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
