The Right Honourable Catherine Margaret, Baroness ASHTON of UPHOLLAND

Lately EU High Representative for Common Foreign and Security Policy and Vice-President of the European Commission. For services to the European Common Foreign and Security Policy

Baroness Ashton took on the newly created role of EU High Representative and has been responsible for the creation of the European Action Service as well as leading the European response to many foreign and security policy crises from the Arab Spring to Ukraine. The EEAS has become an established part of the international diplomatic structures and in her role as High Representative she has worked tirelessly to facilitate an agreement on the future of Iran's nuclear programme. She was previously a successful EU Trade Commissioner and Leader of the House of Lords.

Sir (Robert) John Sawers KCMG

Chief, Secret Intelligence Service. For services to British national security

Sir John Sawers has served for the last five years as the Chief of the Secret Intelligence Service, advising the government and the National Security Council on all the major security and foreign affairs issues during this period and leading the organisation though a major change and modernisation programme. He has previously been the UK's Permanent Representative to the United Nations in New York, Political Director at the Foreign and Commonwealth Office and Her Majesty's Ambassador to Egypt.

HM Ambassador, Moscow. For services to British foreign policy and interests in Russia

Tim Barrow has been at the forefront of managing the complex and important relationship between the UK and Russia during an unprecedented period. Since returning to Moscow in 2012, he has led the Embassy in its work on the crisis in Ukraine and in support to British Olympic and Paralympic teams at the Sochi Winter Games; he has tirelessly promoted UK's interests, including on human rights, fostering cultural and education links between the two countries, and supporting the UK's scientific, trade and economic interests in Russia. This builds on excellence in a long distinguished career including as Ambassador to the EU's Political and Security Committee where he was a leading figure and HM Ambassador to Ukraine where he was paramount in encouraging reform in the country.
