REQUEST FOR INFORMATION: Emails between Defra and members of the Lead Ammunition Group

Thank you for your request for information, which we received on 5 January 2014, about direct emails between Defra and members of the Lead Ammunition Group (LAG) between June 2012 and the date of your request, that focus on the work of the LAG. We have handled your request under the Freedom of Information Act 2000 (FOIA).

Following careful consideration, we have decided not to disclose some of the information falling within the scope of your request.

I enclose seventeen emails that fall within scope of your request.

We are withholding the names of the senders of the enclosed emails and two further emails under the exemption at section 40(2) of the FOIA (personal data relating to a person other than the requester), as the information constitutes personal data relating to a person other than yourself and disclosure would breach the Data Protection Act 1998 (DPA). We consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 to the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute 'fair' processing of the personal data, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA. Therefore, we have concluded that this information is exempt from disclosure under section 40(2) of the FOIA.

In keeping with the spirit and effect of the FOIA and the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on www.gov.uk together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
