For action

Chief Executives: review your responsibilities under the NHS Act 2006

The NHS Act 2006 designates the chief executive of an NHS foundation trust as the accounting officer. The [accounting officer memorandum](#) sets out the accounting officer's responsibilities under the Act, and his or her further duty of being a witness before the Committee of Public Accounts. This is to deal with questions arising from accounts or from reports made to Parliament by the Comptroller and Auditor General under the National Audit Act 1983. **[The memorandum was updated this month to make minor updates to terminology.](#)**

NHS Foundation Trust Annual Reporting Manual 2013/14

We have updated [the NHS Foundation Trust Annual Reporting Manual](#). It provides guidance on producing your annual reports and accounts.

RTT cross border activity in the Risk Assessment Framework – clarification

We want to ensure you are clear about the standards we use as part of our assessment of governance at NHS foundation trusts, and to stress that the data you report to us should be aligned with data reported to NHS England and other national bodies.

As set out in the [Risk Assessment Framework](#), we use a limited set of national access and outcome objectives as part of our assessment of governance at NHS foundation trusts. None of the indicators are developed by us, but reflect those specified in, for example, the *NHS Outcomes Framework*, the *NHS Constitution* and the *Mandate to NHS England*. This means providers are held to a single and clear set of standards by all bodies. While the purpose for which the standards are used may differ, the standards themselves are the same. We therefore ask NHS foundation trusts to report to us in accordance with those nationally-defined standards.

Cross-border activity

Some NHS foundation trusts, particularly those located near the Scottish and Welsh borders,

have queried whether patients from non-English commissioners should be included in their access targets submissions for, for example, the 18 weeks Referral to Treatment Times (RTT) target. ‘Non-English commissioned activity’ is excluded from the publication of RTT data, and from any assessment of the performance of NHS organisations against the English waiting time standards. You should therefore report to us compliance (or otherwise) with the same standards against which you submit for NHS England reporting (ie what you are commissioned to provide by English CCGs). This is to ensure trusts report against a consistent standard.

We would like to reiterate that while the RTT standards in England only apply to patients who reside in England or are registered with an English GP, hence the clarification above, we would not expect any NHS foundation trust to leave patients waiting longer for treatment simply because they are registered with a GP from elsewhere within the UK. If you have any practical concerns about this, please contact your relationship manager.

For action

Change to process for collecting responses to standard questions on quarterly performance

As part of our quarterly monitoring process, we ask about your financial and operational performance. Last quarter, for the first time, we asked you to respond through an online survey. This significantly reduced the time spent analysing your responses and provided data which can be more readily analysed compared to previous quarters.

Thanks to the 142 trusts who provided submissions. Your responses help inform our understanding of both financial and operational risk at your foundation trust. Please note this is an obligatory element of the quarterly monitoring process.

80% of trusts were either neutral or leant towards the survey being convenient. We will therefore use an online survey to collect responses from now on, and should have addressed the initial teething problems. A summary of the comments you shared with us about the survey and our responses is now available on your trust portal.

Complaints cases subject to litigation, inquests and other serious investigations – clarification of position from DH

The Local Authority Social Services and National Health Service Complaints (England) Regulations 2009 removed a specific exclusion included in the 2004 Complaints Regulations which prevented a complaint being considered if the complainant stated in writing that they intended to take legal action. Complaints in these circumstances must now be handled in accordance with the 2009 Complaints Regulations. Some NHS organisations are routinely putting the investigation of a complaint on hold if legal action is mentioned. This is not acceptable. Find out more [here](#).

Leadership Alliance for the Care of Dying People: update before Liverpool Care Pathway ends in July

Last year, the Leadership Alliance for the Care of Dying People was established to lead and provide a focus for improving the care for patients nearing the end of life and their families. The Alliance formed following the [independent review of the Liverpool Care Pathway](#), which recommended the Pathway (that had been used to varying standards to manage end of life care) be phased out.

To give as much notice as possible to health and care professionals to support planning before the Liverpool Care Pathway is phased out in July 2014, [the Alliance has published this statement](#). This also updates on the Alliance’s work so far.
