CDM 2015

The Health and Safety Executive (HSE) has published draft guidance on the legal requirements in the Construction (Design and Management) Regulations (CDM 2015).

Subject to parliamentary approval, CDM 2015 will come into force on 6th April 2015. These will replace the existing CDM 2007 regulations. The guidance is designed to help anyone who has duties under these regulations and to help them prepare in advance.

Serious Incident on the A21

On the 16th January 2015 a young operative, Dale Pentney, working on behalf of the Highways Agency, has been fatally injured while working on renewing barrier on the A21 in Kent.

Commenting on his blog, the Highways Agency Chief Executive, Graham Dalton had these words;

'We have done an immense amount over the last few years to make our network a safer place to work. There was a time, a good few years ago, when we took the view that our contractors are responsible for the safety of their workforce. We take a more responsible view now, and recognise the role that we play in raising standards across all the contractors who work for us. Better than that, we influence safety standards right across the highways sector, and play our part in the wider construction industry.

Our accident frequency rate is well under half what it was six or seven years ago. Getting better is good. But it isn't good enough. I think we work harder than many at improving safety, and I know that our safety record stands up well against other big infrastructure businesses. Yet this week one of our community has been fatally injured at work. Now all I can do is turn again to doing what I can to make this a safer industry to work in.'

The Highways Agency and all its Partners would like to extend our condolences and deepest sympathy to the family and work colleagues of Dale Pentney.
