Hub announces launch of top risk champions and campaigns

This month's briefing is going to concentrate on our new approach.

The hub team is refreshing its approach to preventing harm from injury and ill health. In 2014 the team concentrated on improved engagement with the construction and maintenance community through the review and revision of the raising the bar guidance which defines minimum requirements for working following industry best practice.

This year the hub team aims to further improve engagement and focus on the elimination or control of the fatal risks that our people are exposed to.



Previous safety alerts can be found here https://www.gov.uk/government/publications/highways-agency-safety-alerts There are currently around 9000 people working on our network daily who are exposed to fatal risks while carrying out their jobs in construction and maintenance. We have to improve our health and safety performance if we are to avoid seeing a significant increase in workers killed or seriously harmed as our investment programme grows.

The top risks have been identified and to address them the hub have appointed 'champions' who will focus on how best to eliminate or control exposure. The champions will consist of both delivery and Highways England partners working together.

Services campaign



Our first campaign aims to raise awareness of the risks associated with working near underground services. We expect all our partners to engage in a services avoidance Going **underground?** campaign commencing with a safety briefing during week commencing 11 May 2015. The session will include a film covering real life events and is aimed at all direct employees and delivery partners

Why?

The focus on this risk is because there have been a number of fatalities on UK construction sites and we have had repeated service strikes on our own project sites:

- 113 service strikes have been recorded on the Highways England network over the last 18 months.
- 49 of these strikes were due to poor planning or failure to follow procedures.

It is important that we plan our work and have procedures in place to prevent service strikes. This campaign encourages us to stop and look at what we do, and how we do it. Most importantly we need to speak to those who do the work. They will have valuable ideas which will make the working around services safer.

The campaign

The campaign will span 3 months, the first month we will concentrate on planning work activities. The second month will be looking at control measures and best practice across the industry. The final month will review lessons learnt and how we embed in to working methods.

CONDUCTIVE METAL SETTING OUT PINS ARE BANNED ON ALL HIGHWAYS AGENCY SITES Conductive metal setting out pins are banned on Highways Agency sites. Alternative means of marking could be non conductive pins, free standing pins of carbon fibre, paint or marker flags. There are many products within the industry and these alternatives should be used.
