This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the right of way should be diverted.

The landowner will defray all costs which are incurred in bringing the new site of the path into a fit condition for use by the public

Maldon District Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way known as Footpath 13 over the land situated in the Parish of Wickham Bishops in the District of Maldon and shown by a bold continuous line on the plan numbered WBISH 13A contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 35 days from the date of confirmation of this Order.

2. At the end of 28 days from the date of confirmation of this Order there shall be a public footpath over the land situated at Ballards in the Parish of Wickham Bishops in the District of Maldon described in Part 2 of the Schedule and shown by a bold broken line on the plan numbered WBISH 13A contained in this Order.

Route to Close A-B

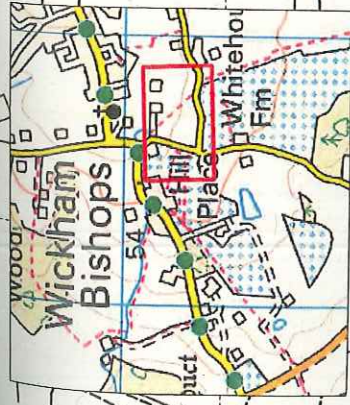
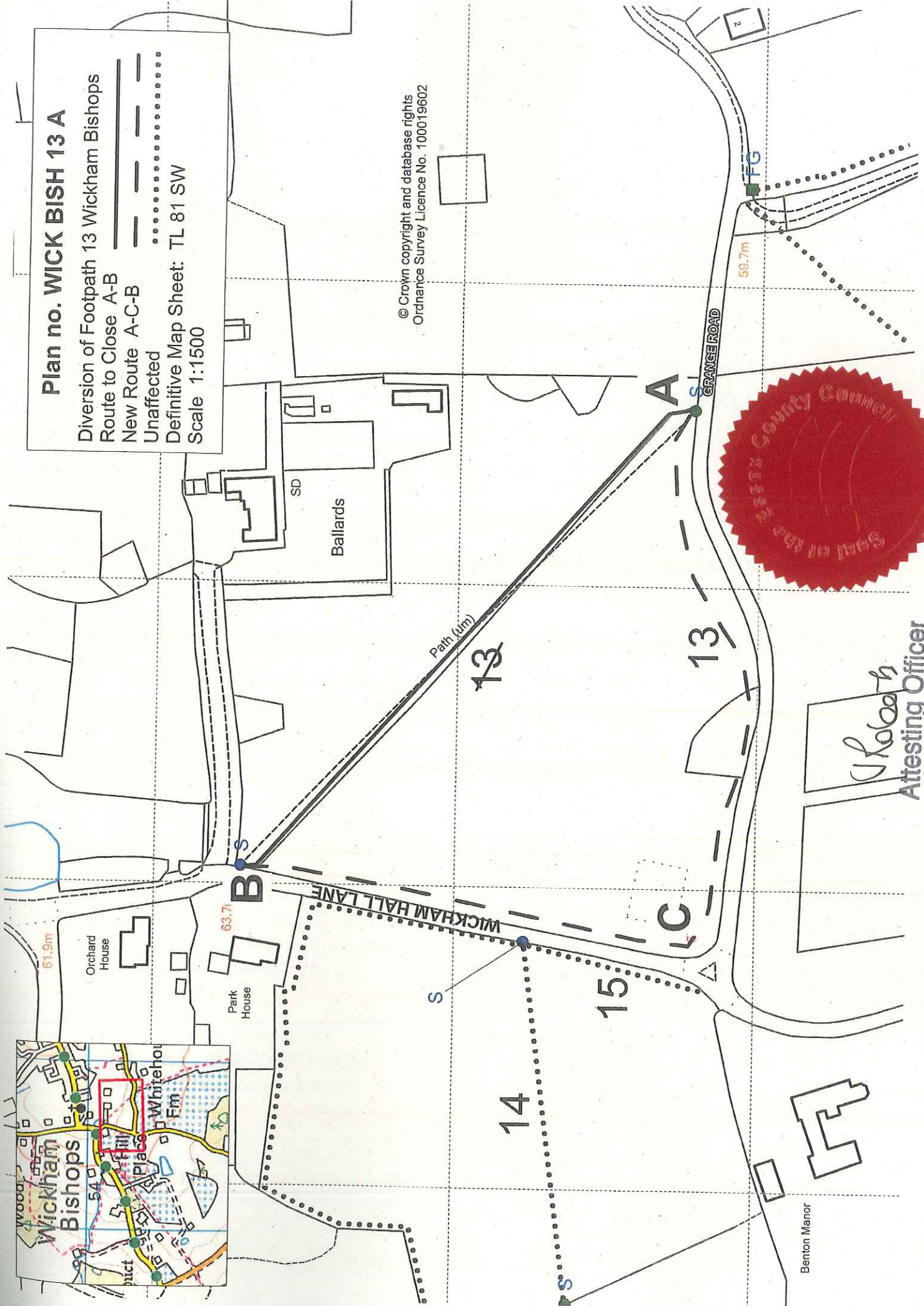
New Route A-C-B

SCHEDULE

[PART 1]

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 13 Wickham Bishops of undefined width and shown by a bold black continuous line on the Order Map starting from point **A** on Grange Road at grid reference 8375,1172 and running in a north westerly direction across the field for a distance of 213 metres to point **B** at grid reference 8360,1186 where it connects to the highway known as Wickham Hall Lane.

[PART 2]

DESCRIPTION OF SITE OF NEW PATH OR WAY

A Footpath being 2 metres in width shown by a bold black broken line on the Order Map commencing at the aforementioned point **A** and running in a generally westerly direction along the field boundary for a distance of 185 metres to point **C** at grid reference 8358,1172 and then in a northerly direction along the field boundary for a distance of 154 metres to the aforementioned point **B**.
