WILDLIFE AND COUNTRYSIDE ACT 1981**

**The Definitive Map and Statement of Public Rights of Way for the County of  
Huntingdonshire dated 9 September 1953 as reviewed at 14 December 1961**

**The Cambridgeshire County Council (Public Footpath No.1, Denton &  
Caldecote) Definitive Map Modification Order 2011**

This Order is made by Cambridgeshire County Council ("the Authority") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement of Public Rights of Way for the County of Huntingdonshire dated 9 September 1953, as reviewed at 14 December 1961, require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) of the Act, namely, the discovery of evidence by the Authority which (when considered with all the other evidence available to them) shows that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The Authority has consulted with every local authority whose area includes the land to which the Order relates. The Cambridgeshire County Council hereby orders that:

1. For the purposes of this Order the relevant date shall be the date on which this Order is made.
2. The Definitive Map and Statement of Public Rights of Way for the County of Huntingdonshire dated 9 September 1953, as reviewed at 14 December 1961, shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Cambridgeshire County Council (Public Footpath No.1, Denton & Caldecote) Definitive Map Modification Order 2011

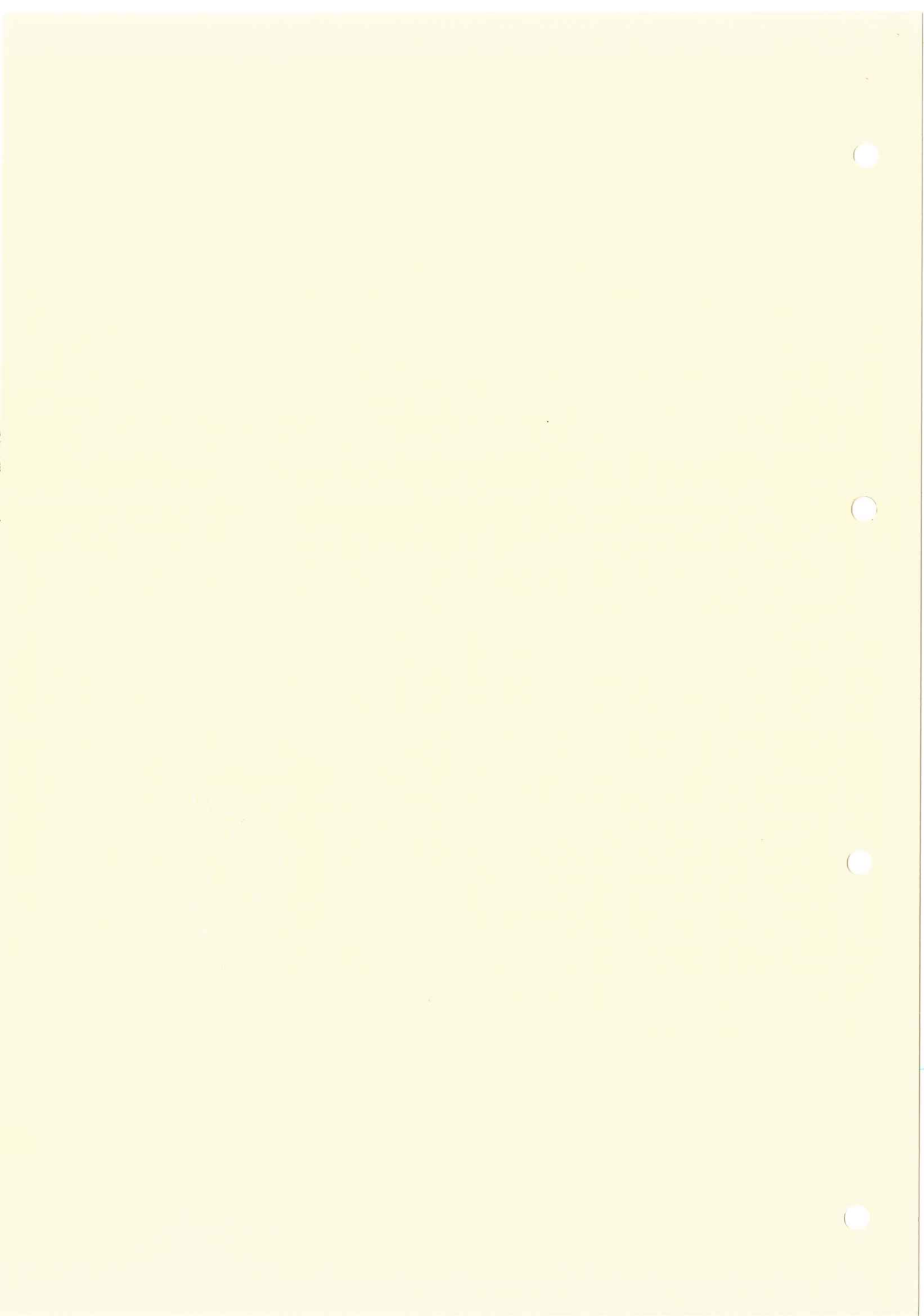

Position of path as indicated on the plan	Description	Dimensions
<b>A - B</b>	A Public Footpath in Denton, from the north side of the public vehicular highway opposite the disused All Saints church at TL 1501 8788 (point <b>A</b> on the Order map), running north across a culvert, through the yard of Red Hill (formerly Rectory) Farm, to join the presently recorded terminus of Denton & Caldecote Public Footpath No.1 at TL 1502 8793 (point <b>B</b> on the Order map).	Length: approx 50m. Width: 3 metres.

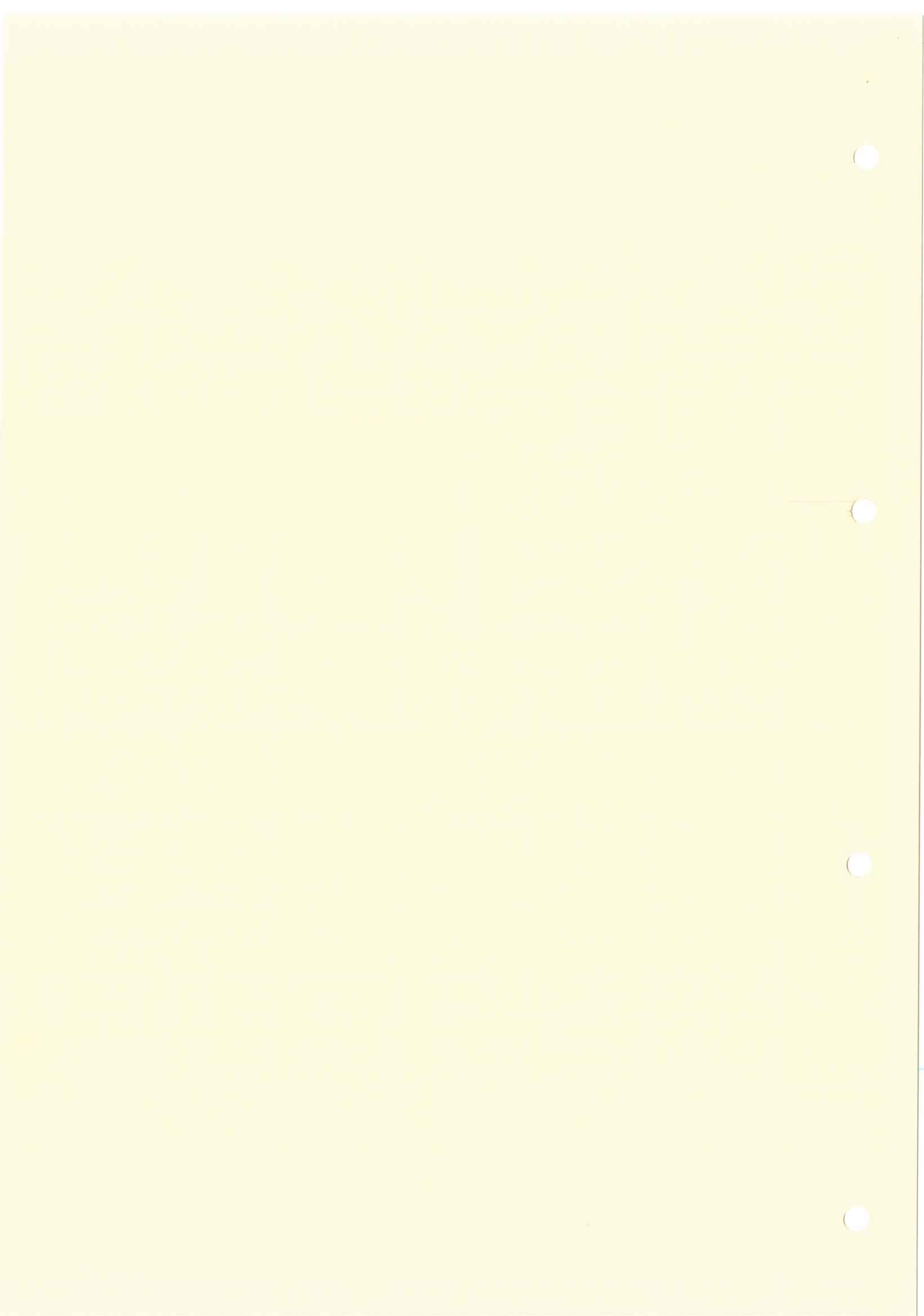
#### Modification of Definitive Statement

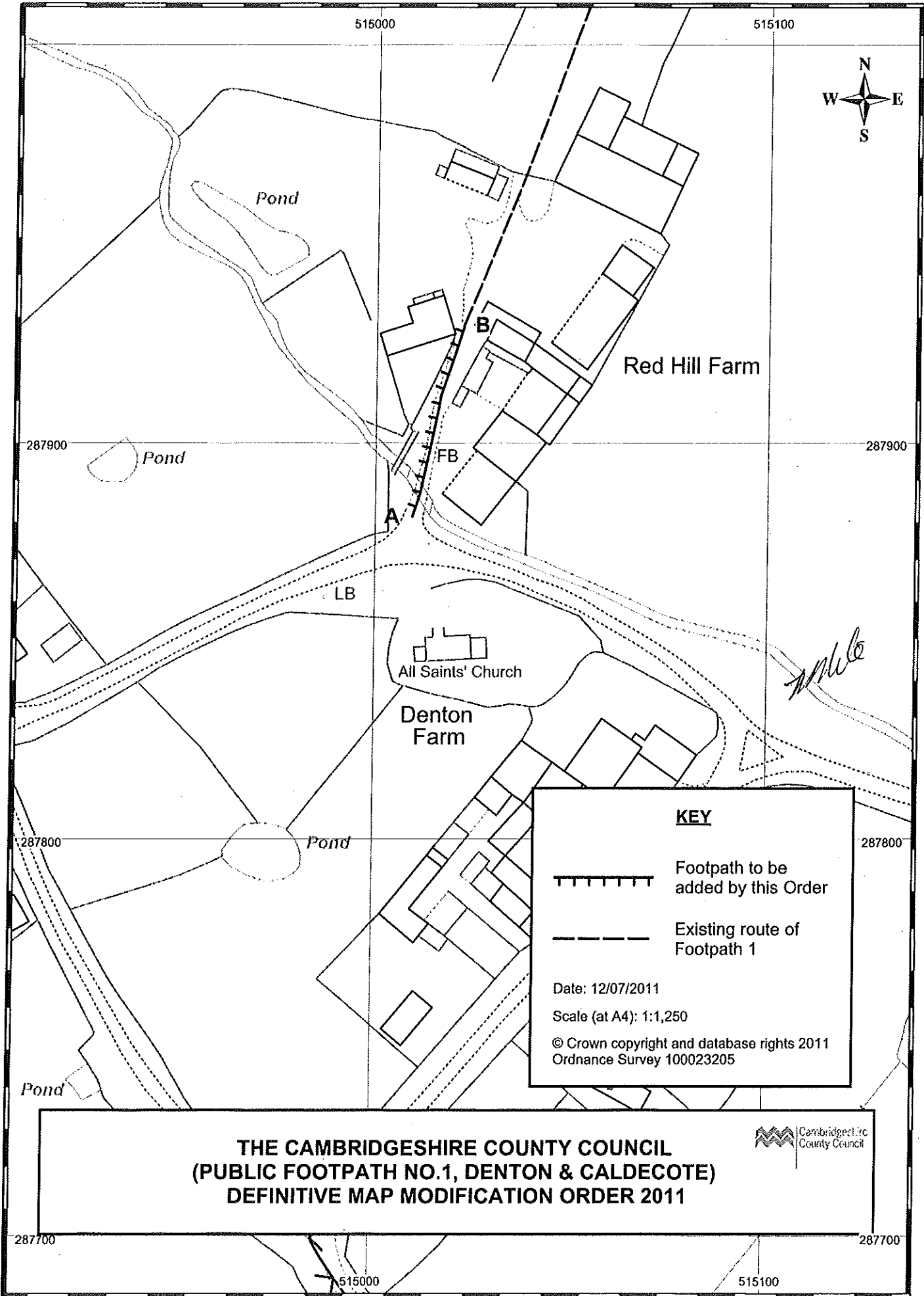
Denton &

Starts on the north side of the public vehicular highway opposite the disused All Saints church at TL 1501 8788, runs north across a culvert, through the yard of Red Hill (formerly Rectory) Farm and continues in a generally northerly direction, terminating at the Stilton parish boundary.



Length: approx 640 metres.

Width: 3 metres between TL 1501 8788 and TL 1502 8793.



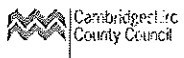


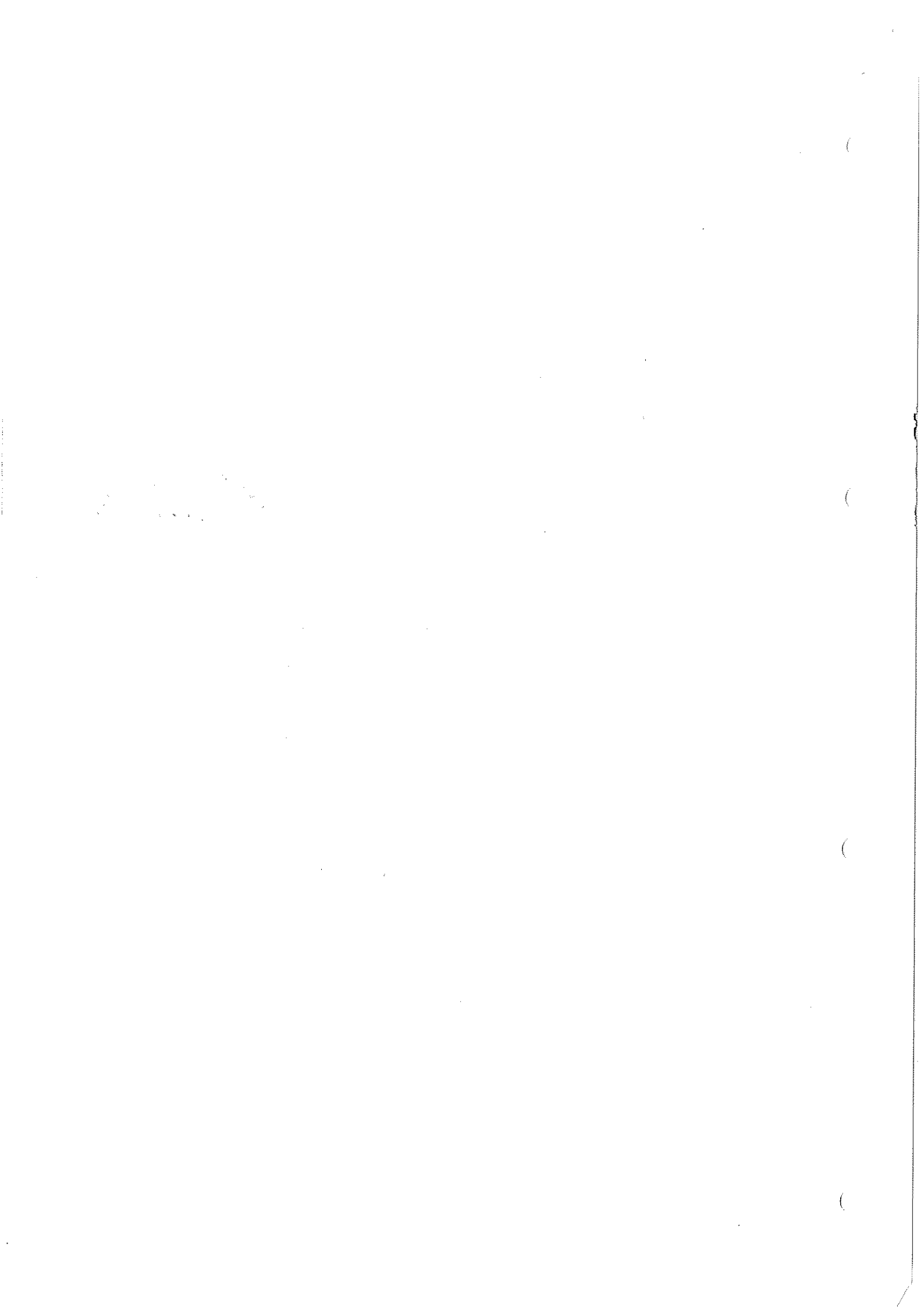

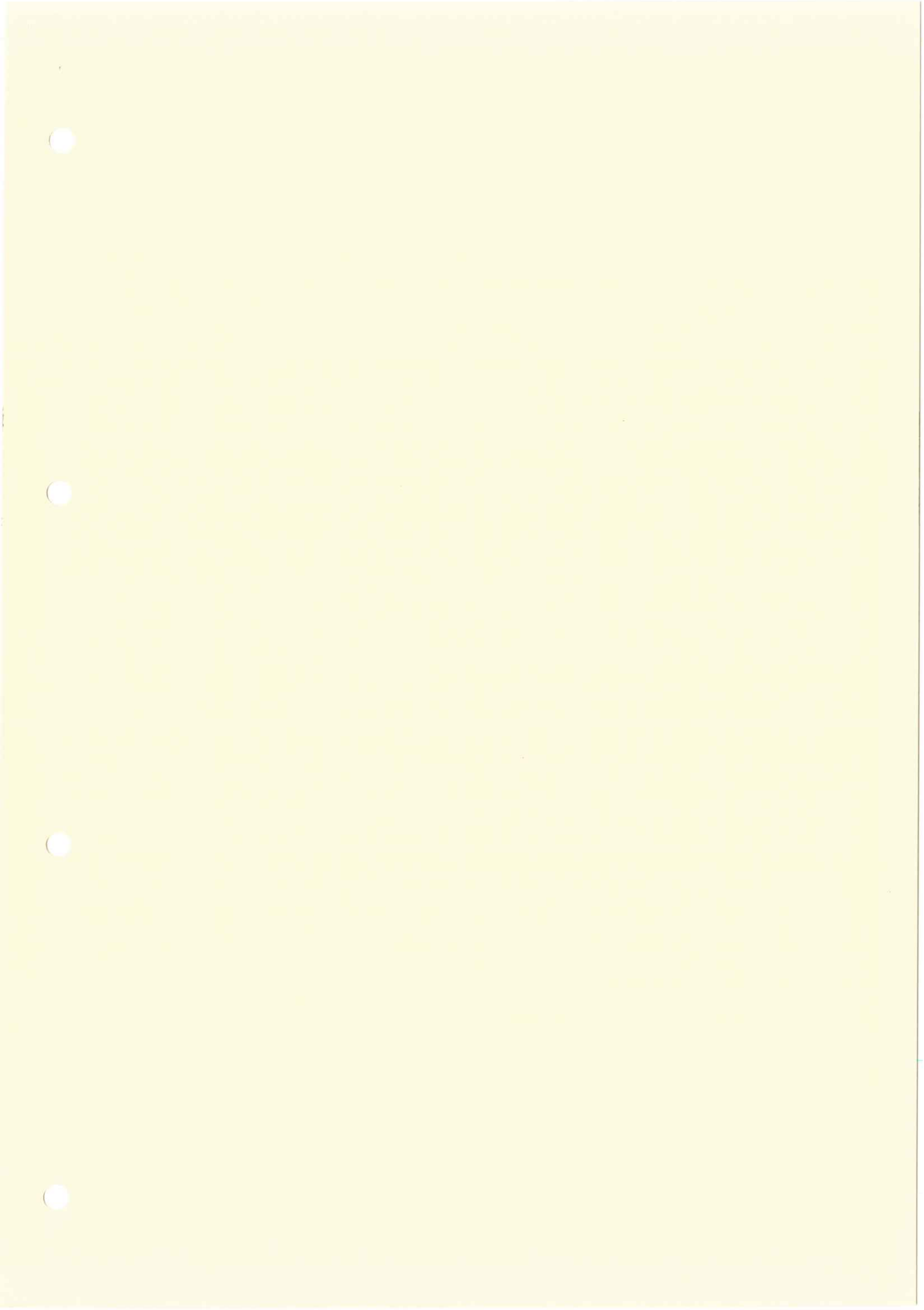
 Footpath to be added by this Order
