

PUBLIC PATH DIVERSION ORDER
HIGHWAYS ACT 1980

NORFOLK COUNTY COUNCIL (WITTON FOOTPATH No.15)
DIVERSION ORDER 2015

This Order is made by Norfolk County Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the Owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Witton and Ridlington Parish Council and North Norfolk District Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public footpath over the land situate at Witton and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to the Order shall be extinguished after 42 days from the date of confirmation of this Order.
2. There shall at the end of 42 days from the date of confirmation of this Order be a public footpath over the land situate at Witton as described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH

Footpath No. 15 the full width of the footpath which starts from grid reference TG 3107 3029 point B on annexed map running in a south south-easterly direction across fields and through farm buildings, then across the garden to the C503 North Walsham Road at grid reference TG 3117 2980 point C on annexed map. The length of the footpath is 494 metres.

PART 2

DESCRIPTION OF SITE OF NEW PATH

Footpath No.15 Starts at the junction with Witton Bridleway 14 at the parish boundary at map reference TG 3107 3029 (point B on annexed map) and runs across a grass field in a south south-westerly direction for 172 metres to map reference TG 3104 3012 (point U on annexed map). The footpath then turns to run in a south south-easterly direction across a grass surface alongside the hedge for 223 metres and then turns in an easterly direction at map reference TG 3107 2989 (point X on annexed map) to a field gate. From this point the footpath runs in a south south-easterly direction along a grass surface track for 43 metres to a field gate at map reference TG 3108 2985 (point Y on annexed map). The footpath then continues along this track for 108 metres to map reference TG 3113 2976 (point Z on annexed map) where it meets the C503 North Walsham Road.

The width of the footpath from map reference TG 3107 3029 to map reference TG 3113 2976 is 2 metres except where it passes through the field gates at map references TG 3107 2989 and TG 3108 2985 where it has a width of 3 metres.
