**PUBLIC FOOTPATH NO. 282 (KEIGHLEY)
BETWEEN LAYCOCK LANE AND CHAPEL LANE LAYCOCK KEIGHLEY
(MODIFICATION) ORDER 2013**

This Order is made by the City of Bradford Metropolitan District Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the modified definitive map and statement for the Metropolitan County of West Yorkshire require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part of the Act applies.

The authority have consulted with every local authority whose area includes the land to which the Order relates. The City of Bradford Metropolitan District Council hereby order that:-

1. For the purpose of this Order the relevant date is 9th July 2013.
2. The modified definitive map and statement for the Metropolitan County of West Yorkshire shall be modified as described in Part I and Part II of the Schedule and shown on the map 66660/T36 attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "City of Bradford Metropolitan District Council (Public Footpath No. 282 (Keighley) between Laycock Lane and Chapel Lane, Laycock Keighley) (Modification) Order 2013".

SCHEDULE

**PART I
MODIFICATION OF DEFINITIVE MAP**

Description of path or way to be added

A Public Footpath in the former Urban District of Keighley (Bradford) as shown by a broken black line with short intervals on the map annexed hereto commencing at point A on Laycock Lane

Continuing from point A in a north westerly direction for 4 metres with a width of 1.3 metres and an earth surface to point B. There is a pinch point in the width at point B which reduces the width to 1.1 metres.

Continuing from point B in a generally north westerly direction for 12.5 metres with an initial width of 1.3 metres and an earth surface, tapering to a width of 0.9 metres at point C.

Continuing from point C in a generally north westerly direction for 8 metres with an initial width of 0.9 metres and an earth surface, tapering to 0.5 metres at point D.

Continuing from point D in a generally easterly direction for 3 metres with a width of 0.5 metres and an earth surface, widening to 0.65 metres at point E. There are two small steps at point E. The steps are 0.6 metres wide, the first is 10cm high and the second is 20cm high.

Continuing from point E in a generally north westerly direction for 4.5 metres with a width of 0.65 metres and an earth surface grid to point F.

Continuing from point F in a generally north easterly direction for 9 metres with a width of 0.9 metres and an earth surface to point G on Chapel Lane.

The route will be Public Footpath 282 (Keighley)

Distances have been measured on the ground.

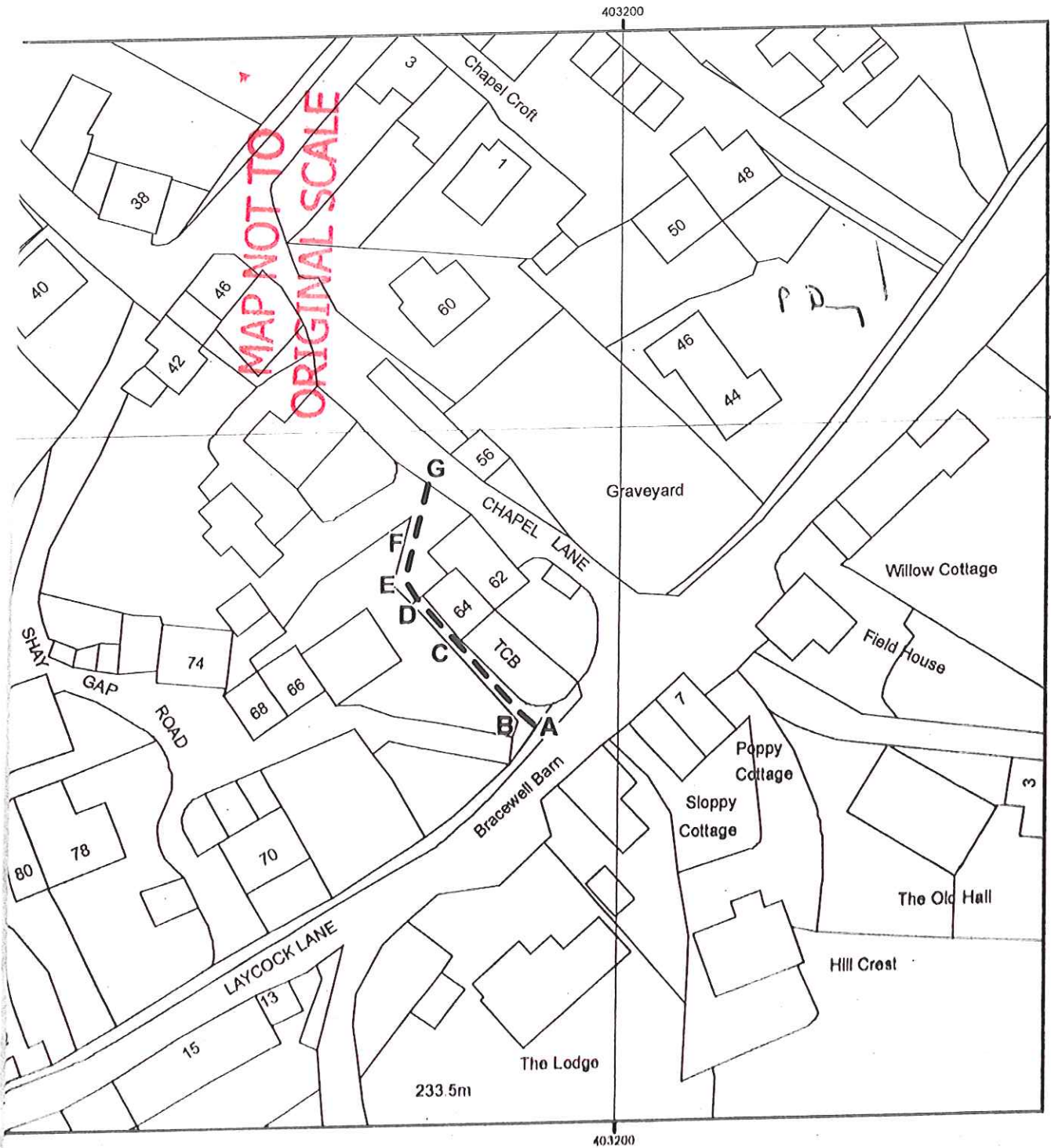
