Dear [REDACTED],

Thank you for your e-mail of 6 July asking for details of aircraft based at RAF Cranwell and RAF Wittering.

You requested the following information:

".....a list of all aircraft currently based at RAF WITTERING and RAF CRANWELL complete with serials,squadron/flight and squadron code."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held and is shown below.

RAF Cranwell is currently the home base for the following military registered aircraft:

RAF Cranwell is also home to the following flying squadrons; 57(Reserve) Squadron, 674 Squadron Army Air Corps and 703 Sqn Royal Naval Air Service. These units are training units and fly

contractor owned Grob Tutor light aircraft. Aircraft numbers and details vary and they are shared between the various units. They do not have military tail codes or squadron codes.

RAF Wittering is home to 16(Reserve) Squadron, 115(Reserve) Squadron, 5 Air Experience Flight, University of London Air Squadron and Cambridge University Air Squadron. As with RAF Cranwell, the aircraft are contractor owned and the aircraft do not have military tail codes or squadron codes.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that both 5(AC) Squadron and 14 Squadron are based at RAF Cranwell on a temporary basis whilst programmed repairs are undertaken to the runway at RAF Waddington. Also, whilst the number of Grob Tutor aircraft at both stations fluctuates according to service needs, typically there are 16 Grob Tutor aircraft permanently based at RAF Wittering and 18 at RAF Cranwell. The 45 (Reserve) Squadron King Air B200 aircraft are military registered but contractor owned. There is one civilian registered, contractor operated Beech King Air 350C aircraft at RAF Cranwell which is used for flying currency training.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
