Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by:

- 1. Upgrading to a restricted byway part of Bridleway 18, Charminster in the West Dorset District, from its junction with Bridleway 16, Charminster at Charminster Down at SY 66199477, generally south for a distance of 280 metres to its junction with Bridleway 3, Stratton at SY 66209449. The width of the restricted byway is 30 feet (9 metres). Limitation: Gate at SY 66209449.
- 2. Varying the particulars relating to the remaining part of Bridleway 18 to reflect this modification.

Within 8 weeks of the start date [by 25 November 2015]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 6 January 2016]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.
