**County of Dorset Definitive Map and Statement of Rights of Way**

**Dorset County Council (Upgrading of part of Bridleway 18, Charminster to Restricted Byway) Definitive Map and Statement Modification Order 2013**

This Order is made by Dorset County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Dorset Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(ii), namely, that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description and in section 53(3)(c)(iii), namely, that any other particulars contained in the map and statement require modification.

The authority have consulted with every local authority whose area includes the land to which the order relates. The Dorset County Council hereby order that:

1. For the purposes of this order the relevant date is 21 December 2012.
2. The County of Dorset definitive map and statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Dorset County Council (Upgrading of part of Bridleway 18, Charminster to Restricted Byway) Definitive Map and Statement Modification Order 2013".

**Part I**

**Modification of definitive map  
Description of way to be upgraded**

**Part of Bridleway 18, Charminster in the West Dorset District to be upgraded to restricted byway:**

From its junction with Bridleway 16, Charminster at Charminster Down at point A (SY 66199477), generally south for a distance of 280 metres to its junction with Bridleway 3, Stratton at point B (SY 66209449).

Width: 30 feet (9 metres)

Limitation: Gate at point B SY 66209449

**Modification of definitive statement  
Variation of particulars of way**

**Bridleway 18, Charminster**

From: SY 66129590 To: SY 66199477

From its junction with Bridleway 22 at Watcombe Bottom, southwards to its junction with Bridleway 16 and the Restricted Byway.

**Restricted Byway at Charminster**

From: SY 66199477 To: SY 66209449

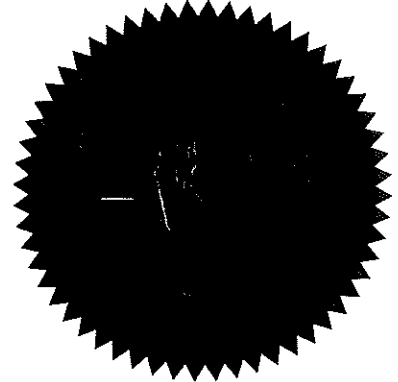
From its junction with Bridleways 16 and 18 at Charminster Down, generally south for a distance of 280 metres to its junction with Bridleway 3, Stratton.

Width: 30 feet (9 metres)

Limitation: Gate at SY 66209449

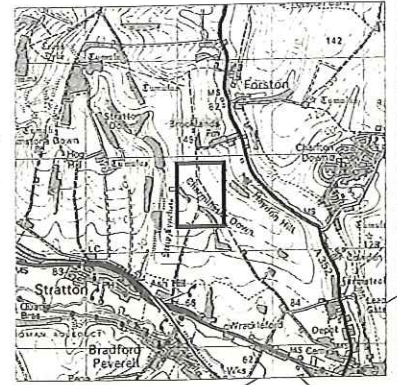
