

# NOTICE OF ORDER

## HIGHWAYS ACT 1980 SECTION 119

Essex County Council  
Public Path Diversion Order 2015 Footpath 95 Ashdon in the District of  
Uttlesford

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 16 September 2015.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert the path away from the buildings and residence of New House Farm to an alternative route around the perimeter of the adjacent field, already being used by the public. The route of the definitive line of the path commences at grid reference 55916,23898 south of New House Farm and runs in a north westerly then a south-westerly direction for a distance of 85 metres to grid reference 55910,23898 and then in a north westerly direction along the property boundary by New House Farm Cottage for a distance of 140 metres to grid reference 55900,23907 where it connects to New House Lane. The alternative path, 2 metres in width, commencing at the same above mentioned point and runs in a west south westerly direction for a distance of 141 metres to grid reference 55904,23892 and then continues in a north westerly direction for a distance of 160 metres to grid reference 55892,23902 and then in a north easterly direction for a distance of 64 metres to grid reference 55895,23907 where it connects to New House Lane.

**Timetable for sending in statements of case and comments**  
**Within 2 weeks of the start date [by 30 September 2015]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

**Within 8 weeks of the start date [by 11 November 2015]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

**Within 14 weeks of the start date [by 23 December 2015]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
