Who we are

Ofsted is best known for inspecting places where young people go to school or college to make sure they are getting the best possible education. You might have met an Ofsted inspector at your school or college.

We don't just inspect schools and colleges. Ofsted is now working with the Care Quality Commission to find out how well young people's special educational needs are being met in the area where they live. We call this a local area.

The Care Quality Commission is like Ofsted but looks at health services, like hospitals, rather than schools and colleges. It is usually called the CQC.
