We have completed the search for the information that you requested. Taking each question in turn please find enclosed our response below.

- 1. UKAEA has 5 paintings, which are insured. We have a larger number nominal value artworks and photographs, but we do not hold lists/records of these.
- 2. The total insurance value of the 5 paintings is £823,500.
- 3. The paintings are hung were they may be viewed by the public, but not without prior arrangement. Other artwork is displayed across the site in public areas.
- 4. Of the 5 paintings, 2 were gifts to the UKAEA in the 1950s and the other 3 were either gifts or commissioned pieces to celebrate our history. The last valuation was undertaken in 2010, which estimated the most valuable piece at £400-600k and the least at £2k.

I trust that this provides you with the information that you require.
