PUBLIC PATH EXTINGUISHMENT ORDER 2015 – (No. 3) (Amended)

This Order is made by Amber Valley Borough Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the part of the footpath described in paragraph 1 below is not needed for public use because an alternative route has been provided along the adopted estate road and footway called Bobbin Way.

Derbyshire County Council have been consulted and Derbyshire County Council have consented to the making of this order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at numbers 4 to 10 Bobbin Way, Belper, Derbyshire and shown by a continuous bold line on the plan attached to this order and described in the Schedule to this order shall be extinguished on the date of confirmation of this Order.

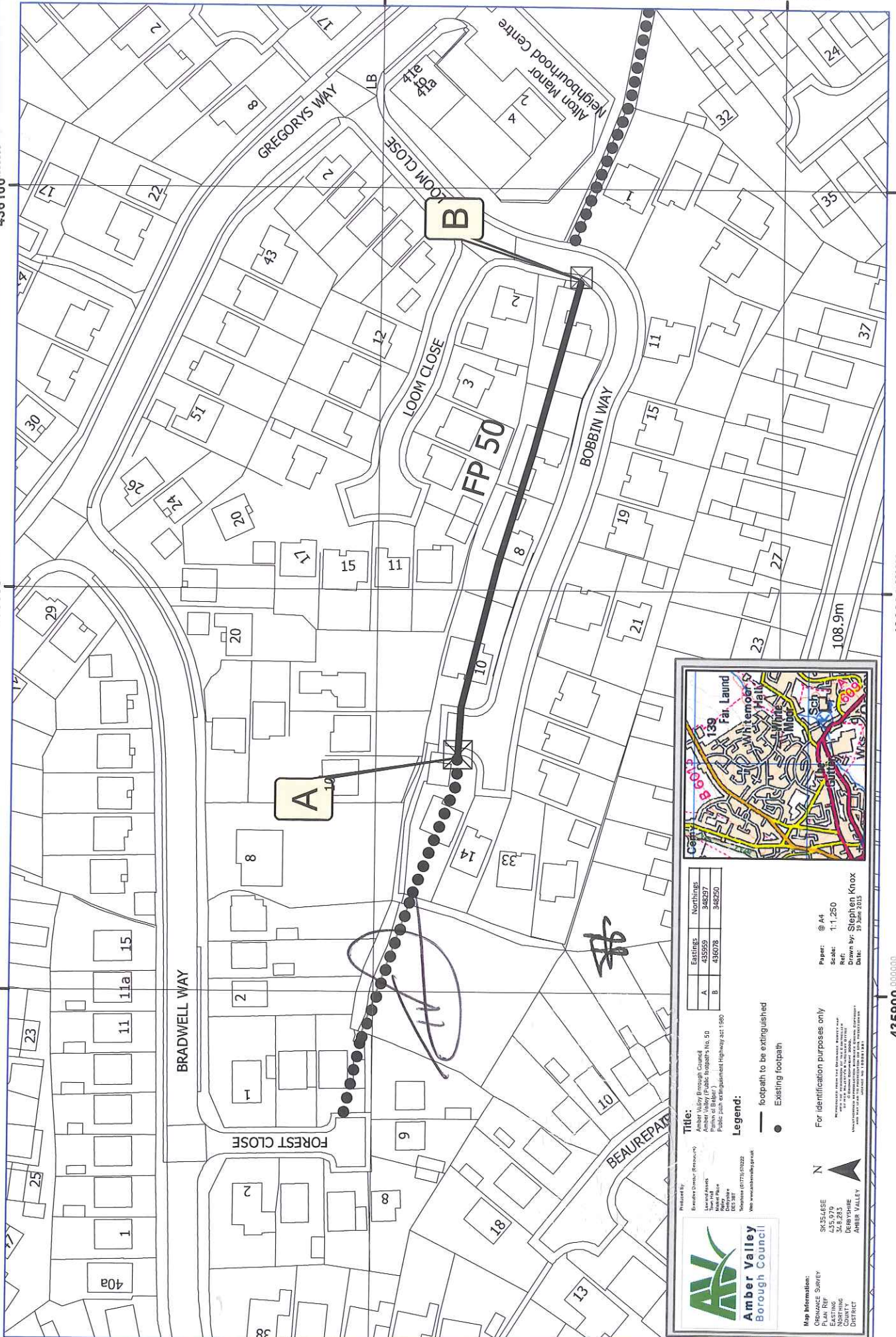
