

NOTICE OF ORDER

HIGHWAYS ACT 1980 SECTION 119

Essex County Council
Footpath 10 Wickham St Paul Public Path Diversion Order 2015

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 10 November 2015.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert a part length of public Footpath 10 in the Parish of Wickham St Paul as shown on the Order map contained in this Order. The definitive line commences from where it connects to Footpath 11 at grid reference 58293,23652 and runs in a generally west-south-westerly direction across a ditch which has no footbridge and very close to Shellards Barn (CO9 2PP) south of the pond and the Barn and across the field and then continues in a northerly direction for a total distance of 186 metres to grid reference 5828, 23650.

The alternative route of the footpath, which is 2 metres in width, commences from the connection to Footpath 11, 40 metres further to the north-west and runs in a westerly direction north of the pond and Shellards Barn and across the field onto adjacent farm land for a distance of 120 metres to where it re-connects to the definitive line at the grid reference 5828, 23650 above.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 24 November 2015]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 5 January 2016]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 16 February 2016]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
