This Order is made by the County Council of Durham under Section 53(2)b of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement of Public Rights of Way of County Durham require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act namely the discovery by the Authority of evidence which (when considered with all other relevant evidence available) shows that a right of way which is not shown on the Definitive Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The County Council of Durham hereby order that:

1. For the purposes of this Order the relevant date is 30 April 2015.
2. The Definitive Map and Statement of Public Rights of Way of County Durham shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. The Order shall take effect on the date it is confirmed and may be cited as The County Council of Durham Public Rights of Way Modification Order No. 2 (Public Footpath No. 77 Consett) 2015.

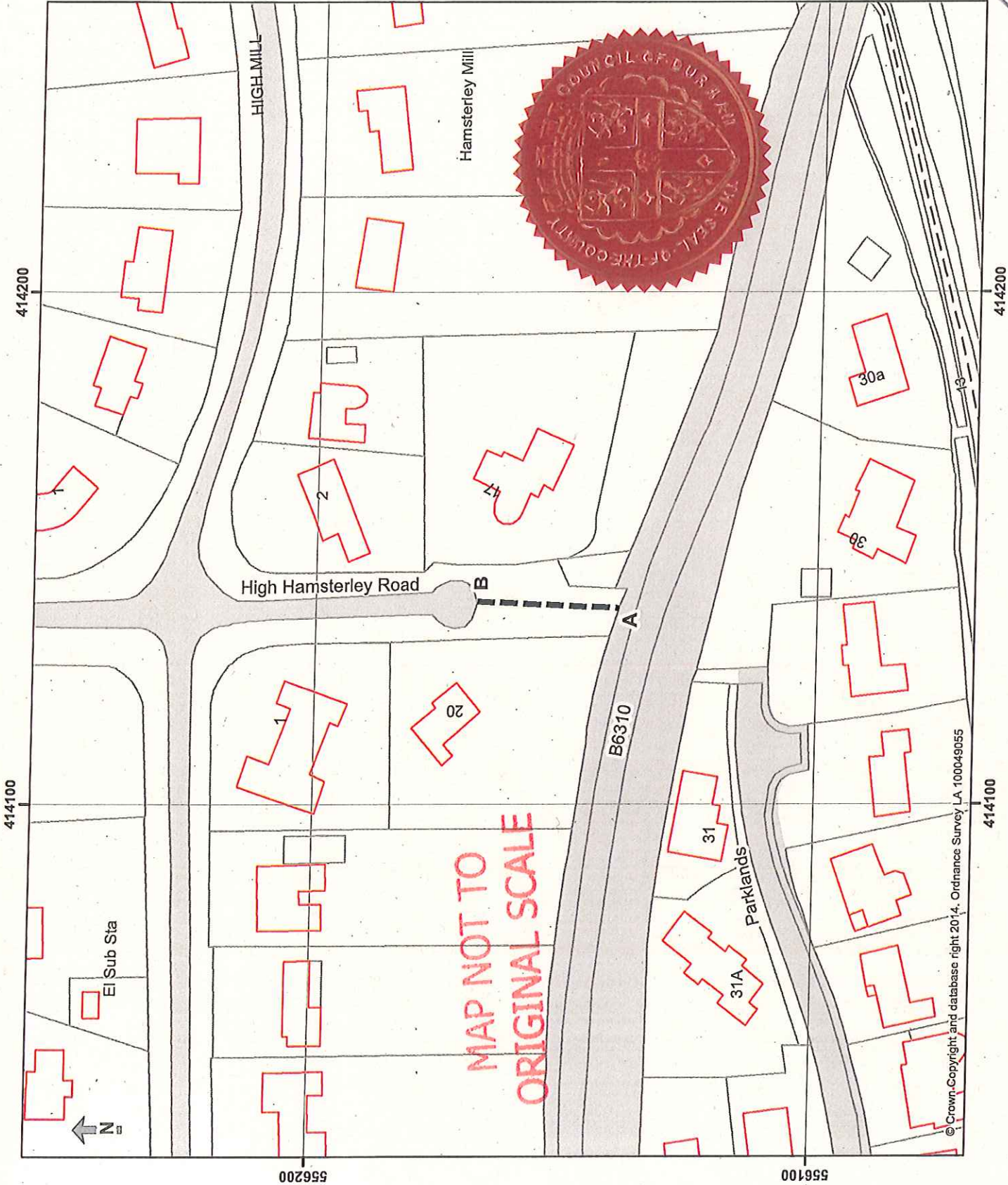
