Dear

Thank you for your letter of 11 June 2012, in which you requested an Internal Review of the Department's response to your request under the Environmental Information Regulations (EIRs), case 12/0495/120323 00BIS489RE001.

I am a Director at DECC with responsibility for the policy area within which your original request fell and, in accordance with Departmental guidelines, your request for an internal review has been referred to me. My task is to consider whether or not your request for information has been considered thoroughly and impartially, within the terms of the Freedom of Information Act.

The original request asked DECC for the search results generated by a number of searches of the Department's record management system for specific keywords. The request did not suggest a specific search strategy (e.g. by title word or document content).

"Please conduct three searches of your records management system for the terms a) "climategate", b) "climate-gate" c) "climate gate" for the period beginning 01 November 2009 and running up to and including March 2012."

*"Please conduct a search of your records management system for the following terms for the period beginning November 2009 and March 2012:
a) "University of East Anglia" and "email hack" b) "UEA" and "email hack"*

Your request was interpreted as a request for information containing the key terms within the title of documents. I have concluded that the Department tried to be as open and clear as possible in its response on how it interpreted and handled the information request - specifying the type of search it ran (title word search).

However, in accordance with your internal review request, and as part of the department's duty to provide advice and assistance to applicants we have now undertaken the additional "document content" searches that you requested in your letter of 11 June.

"This is a request for an internal review following a response to a request under Freedom of Information Act 2000 relating to a searches of DECC's Records Management system... I would be grateful if you could run a search of the Matrix systems for documents where the term Climategate appears anywhere in the document and not just in "document title word".

As you confirmed in your email of 1 July 2012, we have interpreted this request to mean that you would like the Department to run all the searches stated in your original request of 23 March 2012 using the "document content search" rather than the "title word search".

The Department was able to successfully run document content searches for all of the keywords requested. The document content index was searched, and the results exported. The records within the relevant timeframe were then extracted from the list of search results. The search results have been aggregated into the two tables, as appended in Annexes A and B.

Means by which the communication is to be made.

I will now address your statements made under the paragraph "Section 11(1)

"I would, under Section 11(1)(b), request an opportunity to inspect in situ any record containing the information requested."

Your original request was for *"a copy of the search results which includes a summary information as it appears in your records system."*

The department has provided a copy of the search results as far as reasonable. Your original letter of 23 March did not include a request to visit the department and view actual copies of the records included in the search results list, and therefore will not be covered as part of this internal review. If you would like to view any of the records contained in the search results list provided please submit a new information request to the Department.

"I would also like to express a preference for all documents to be supplied electronically as PDFs via email. I would like to express a preference for the information to be communicated to me in a form as close to the original. For example that documents are provided whole with any redactions made rather than content to be pasted into new files."

The information both provided in the department's original response of 24 April 2012 and the additional information provided in this response, has been supplied in pdf format.

Our records management system is an electronic database and the list of search results were extracted from this database and pasted into the pdf letters provided to you.

Appeals procedure

Annex A

Note

Personal data concerning junior government officials and some other individuals have been redacted in accordance with Regulations 12(3) & 13 of the Environmental Information Regulations (EIRs). and Section 40 (to the extent that the information requested is not environmental). Regulations 12(3) & 13 and Section 40 provide an exemption for personal data which then falls to be dealt with under the Data Protection Act 1998. Personal data of third parties can only be disclosed in accordance with the data protection principles. In particular, the first data protection principle requires that disclosure must be fair and lawful and must comply with one of the conditions in Schedule 2 of the Data Protection Act. We consider that to disclose the names of these third parties within the results list would contravene of one or more of those data protection principles. The definition of personal information to which regulation 12(3) & 13 and section 40 applies is wide and can include references to identifiable individuals. Our view is that the release of the names would not be fair and none of the conditions of Schedule 2 are met.
