

# NOTICE OF ORDER

Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Orders.

The **start date** for the above Orders is 31 December 2015.

Consideration of the Orders will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications will be to modify the Definitive Map & Statement for the District of Staffordshire Moorlands by:

- diverting that length of Public Footpath No. 7 Sheen Parish which runs from approximately 16 metres north of Pool Farm at grid reference 409785 362439 in a generally northerly direction across the centre of a field to a point approximately 70 metres west of Ball Ridge Lane at grid reference 40973 362480; to a new line which runs from approximately 16 metres north of Pool Farm at grid reference 409785 362439 in a generally easterly direction for approximately 27 metres to the field corner at grid reference 409814 362441 before heading in a north easterly direction for approximately 11 metres to a footbridge and its junction with Public Footpath No 11 Sheen at grid reference 409815 362452 as shown on the Order map and;
- extinguishing that length of Public Footpath No. 10 Sheen Parish which runs from its junction with Ball Ridge Lane at grid reference 409869 362408 in a generally westerly direction for approximately 107 metres to its junction with Public Footpath No. 7 Sheen at grid reference 409772 362389 as shown on the Order map.

### **Timetable for sending in statements of case and comments**

#### **Within 2 weeks of the start date [by 15 Jan 2016]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

#### **Within 8 weeks of the start date [by 26 Feb 2016]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

#### **Within 14 weeks of the start date [by 08 Apr 2016]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
