NORFOLK COUNTY COUNCIL (ALPINGTON)

MODIFICATION ORDER 2015

This Order is made by Norfolk County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement of Public Rights of Way for the County of Norfolk ("the Definitive Map and Statement") require modification in consequence of events specified in Section 53(3)(c)(i) of the Act, namely:-

- (a) Section 53(3)(c)(i) – the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path or restricted byway

The Authority have consulted with every local authority whose area includes the land to which the Order relates.

The Norfolk County Council hereby order that:-

1. For the purposes of this Order the relevant date is 1 June 2015
2. The Definitive Map and Statement of Public Rights of Way for the County of Norfolk shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Norfolk County Council (Alpington) Modification Order 2015

SCHEDULE

PART I

Modification of the Definitive Map

Description of path or way to be added

Footpath (Church Meadow to Alpington FP11) Starts at the U71019 Church Meadow at map reference TG2911 0209 (point A on annexed map) and runs in a west north westerly direction for 33 metres at a width of 9 metres to map reference TG2908 0210 (point B on annexed map) the footpath then continues across the field in a south south westerly direction at a width of 1 metre for approximately 165 metres to map reference TG2903 0194 (point C on annexed map) and then continues westwards at a width of 1 metre for 25 metres to map reference TG2900 0194 (point D on annexed map) then southwards along the field edge at a width of 1.5 metres for 7 metres to map reference TG2900 0194 (point E on annexed map) then westwards along the field edge at a width of 1.5 metres for 117 metres to a gap in the hedgerow of 1 metre to meet up with Alpington FP11 at grid reference TG2889 0192 (point F on annexed map)


PART II

Modification of Definitive Statement

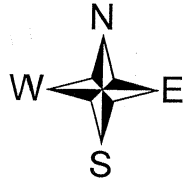
