Thank you for your email dated 18 December 2015. You asked:

I wish to refine my request by just asking the second and third questions from my email dated 6 October 2015.

The second and third questions in that email were:

My second request is the provision of Annex A as mentioned in the final paragraph of page one of your FOIA response dated 3rd June 2014 Ref: 2014/01439 (also attached). Please could you also provide details from 1st March to date.

Thirdly, please provide a summary of the terms under which the Ministry of Defence Disposal Services Authority operates its disposal contract with Agility. Please include any arrangement, sub contract or otherwise between the DSA and Agility and Mr Michael Dipple of Field Textiles Limited; Disposal Services Limited and Military Spares (UK) Limited.

I am treating your email as a new request for information in accordance with the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that information in scope of your requests is held.


