This Order is made by Doncaster Borough Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that The County of the West Riding of Yorkshire (Area 3) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The authority has consulted with local elected members

Doncaster Borough Council hereby order that:-

1. For the purposes of this order the relevant date is the 1st December 2014.
2. The County of the West Riding of Yorkshire (Area 3) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Doncaster Borough Council Public Footpath No 16 Doncaster Definitive Map Modification Order 2014

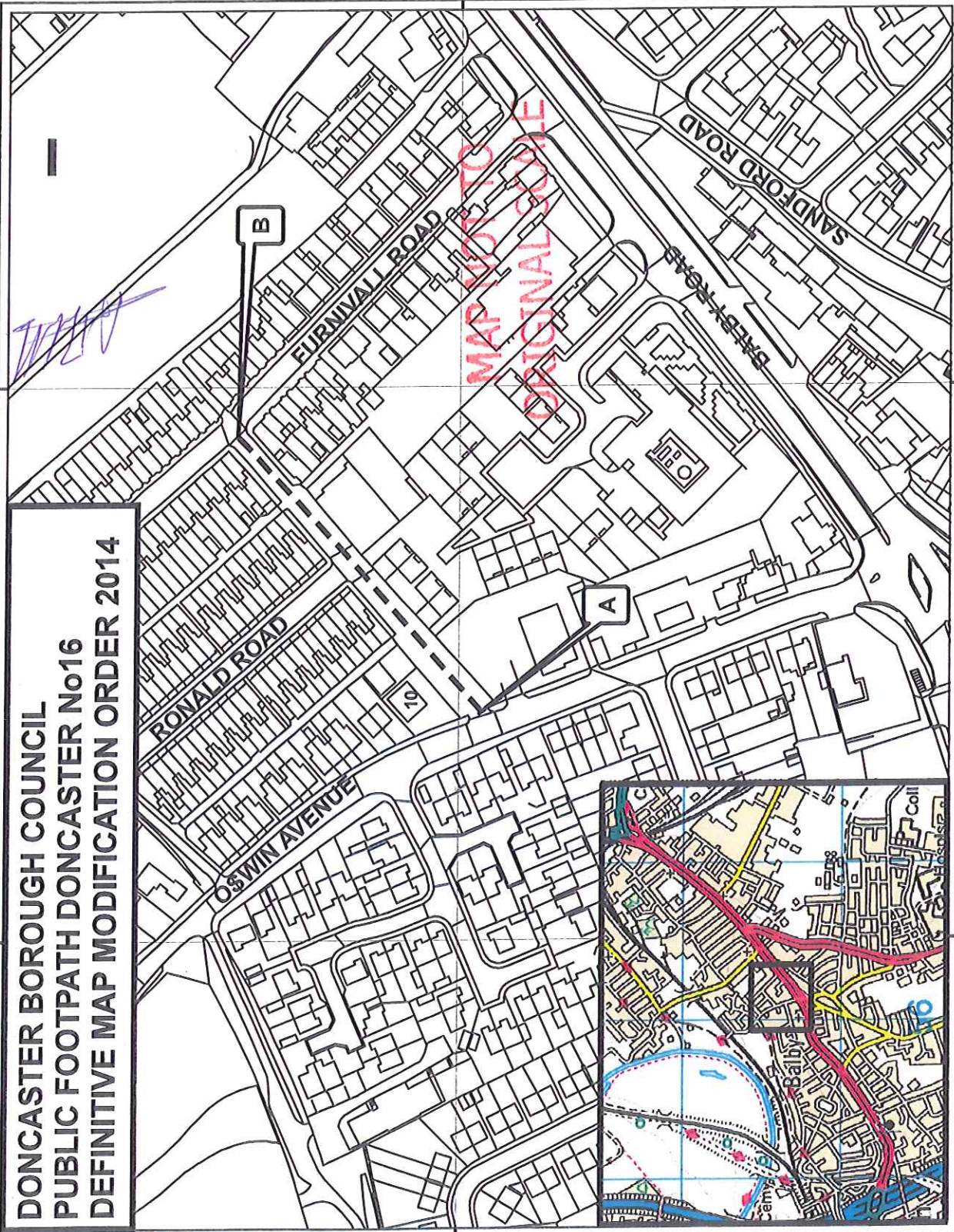

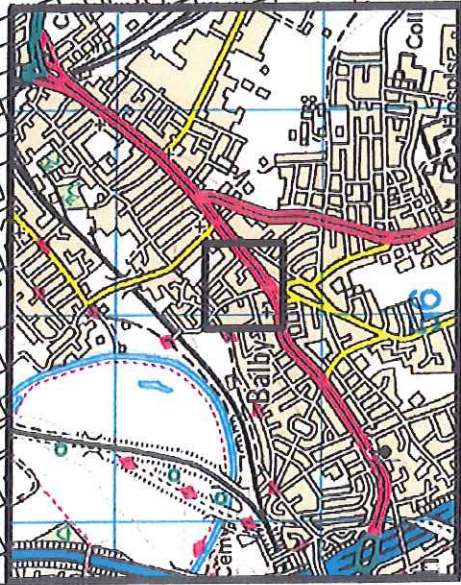
