EXTINGUISHMENT ORDER 2015

This Order is made by Gloucestershire County Council ("the authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that part of the public footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Definitive Map and Statement of Public Rights of Way for Gloucestershire require modification in consequence of the occurrence of an event specified in section 53 (3) (a) (i) of the 1981 Act, namely, the extinguishment (as authorised by this Order) of highways shown or required to be shown in the map and statement.

Cotswold District Council has been consulted to the making of this order as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

1. The public rights of way over the land situate at the Brans Cottage, Brans Lane, in the Parish of Oddington and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be extinguished on the date on which Gloucestershire County Council confirm the Order, and thereupon the Definitive Map of Public Rights of Way for Gloucestershire shall be modified by deleting from it those public rights of way.
2. Notwithstanding this Order, Statutory Undertakers whose apparatus is under, in, upon, over, along or across the highways shall have the same powers and rights in respect of their apparatus as if the Order authorising the highways to be stopped up had not been made.
- 3A. The Definitive Statement of Public Rights of Way for Gloucestershire shall be modified as described in Part 2 of the Schedule to this Order.

SCHEDULE

PART 1

Description of paths to be extinguished

That length of public footpath numbered HOD 9 in the Parish of Oddington that commences at a point marked A on the Order Plan annexed hereto at Ordnance Survey Grid Reference (OSGR) SP 2233/2591 and continues in a generally southerly direction for 238 metres to a point marked B on the said plan at OSGR SP 2237/2568 and being shown by a bold continuous line and having an undefined width.

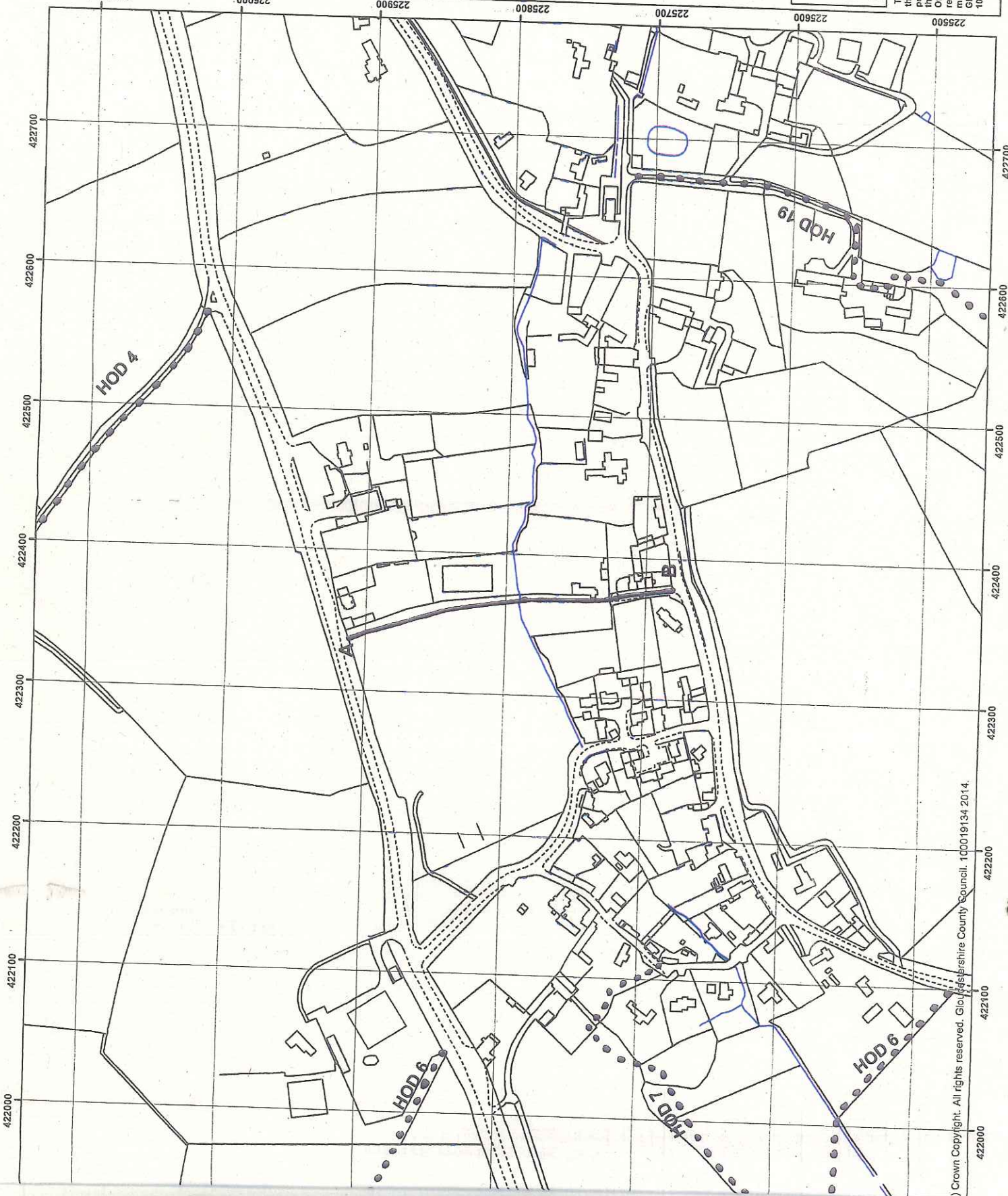
