Number of regional jobs linked to EU exports

1.1 Analysis by HM Treasury estimates that around 3.3 million jobs, out of a total of 33.8 million across the United Kingdom, are linked to exports from the UK to other EU countries. The analysis also estimates how many jobs in each region are linked to exports to the EU.

1.2 The UK estimate is calculated as the sum of direct jobs – ones that are directly involved in exporting– and indirect jobs – those relating to the indirect demand generated in the wider economy as a result of export activities.

1.3 To calculate the number of direct jobs involved in exporting goods to the EU the analysis uses ONS data for the total number of jobs multiplied by the share of gross output that is exported for each industry. There is no data which provides the breakdown of exports by destination for each industry, so the analysis assumes that the proportion of exports to the EU for each industry is the same as the average for the UK. This provides a direct jobs figure of 1.9 million.

1.4 To calculate the number of indirect jobs linked to exports the analysis calculates the amount of indirect output generated in the UK economy per unit of exports using the ONS' industry specific 'output multipliers'. Multiplying total indirect export-related jobs across all sectors by the export share to the EU results in 1.4 million indirect jobs.

1.5 The total number of jobs associated with exports to the EU is therefore 3.3 million.

1.6 The regional breakdown reflects the industrial variation between regions. The results are rounded to the nearest 50,000.

Notes:

- 1. Data on gross output and industry specific output multipliers come from the latest ONS <u>Input-Output Analytical Tables</u>.
- 2. The number of jobs in each industry and region is measured quarterly by the ONS and published in the <u>workforce jobs</u> series.
- 3. The share of exports to the EU is taken from the <u>UK balance of payments</u>, exports to the EU28 (CDID code: L7D7) divided by total exports (KTMW).
- 4. Data on the size and industrial mix of each regional economy comes from the ONS <u>Regional</u> <u>Gross Value Added</u> (Income Approach), December 2015 publication.
- 5. The analysis uses 2010 as a consistent baseline year for all data.
