## Section A: Vehicle details

Make*	For example, Ford, Vauxhall, Peugeot and so on.
Model*	For example, Fiesta Azura Auto, Corsa GLS 12V, 406 GLDT and so on.
Type of body	For example, 2-door saloon, estate, 3-door or 5-door hatchback, sports, convertible, coupe, motorcycle, tricycle, moped, flat lorry and so on.
Colour*	The colour may not be the full manufacturer's description as we only use basic colour descriptions (for example, if the vehicle is lavender it would be shown on the registration certificate, as purple).  Note: where a vehicle has 2 colours, both descriptions should be entered on the V55 form, for example, 'black and white'. For a vehicle with 3 colours or more enter 'multi-coloured'.
Cylinder capacity (cc)*	Take this information from the type approval document or get it from the vehicle manufacturer.
Revenue Weight (kg)	You do not need to give the weight if the vehicle is a car or light van, or if it weighs 3500kg or less.
Mileage (miles)*	You need to provide a mileage reading. Take this information from the vehicle odometer.
Type approval number	Take this information from the type approval document. If the vehicle does not need evidence of type approval because of how it is constructed, leave blank.
VIN/chassis/frame number*	Give the full Vehicle Identification Number (VIN), chassis number or frame number, usually shown on a plate near the engine.
Engine number	Give the full engine number, which you should get from the vehicle.

<sup>\*</sup>Your application will be rejected if you do not provide this information.

## Section B: Name and address of person, partnership, or company responsible for the vehicle

This form should be filled in by the person or organisation who is responsible for the vehicle and should only be used if you cannot obtain a manufacturer's certificate of newness.

You will also need to send us evidence showing the date you collected the vehicle (normally the date of the invoice from the supplier) and how the vehicle was brought into the country (either the temporary registration form if the vehicle was driven, or evidence of transportation if it was transported).

## **Section C: Declaration**

All sections of the declaration must be completed in full and must be signed and dated or your application will be rejected. By signing this form, you are declaring that you are responsible for confirming the newness of the vehicle and that it meets the newness criteria.
