# Notification of a change of name Explanatory note to MQ/33

## Please detach these explanatory notes before returning the form

#### 1. Introduction

The MQ/33 is to be used when the trading title of the whole business that occupies the holding is being changed. This may be because, for example:

- · the quota holder takes on one or more new partners;
- one or more partners leaves the business;
- the name of a Limited Company is being amended;
- the quota-holder has changed their name;
- one member of a partnership dies.

When the trading title on the Milk Quota Register is changed, all benefits and obligations will be carried over to the new trading title. These include:

- full entitlement to the quota;
- entitlement to any compensation payments for past quota cuts that may be due.

The new quota holder will also be responsible for all the obligations of the old quota holder. You must inform your milk purchaser of your change of trading title. You should also inform your landlord and other parties with an interest in your holding.

We will notify you in writing once your trading title has been updated on the Milk Quota Register.

#### 2. The Quota

When you change a trading title using form MQ/33:

- · your new details will be entered on the Quota Register as the quota holder; and
- all rights to the quota will be carried over to the new trading title.

## The details of the old quota holder will be removed from the Quota Register.

If it appears that a new legal entity is now entitled to the quota, a new Trader registration number will be needed. You will be asked to apply for a new registration by contacting our Customer Service Centre on 0845 603 7777 and complete form MQ/1 to transfer the quota to the new registration.

Situations that would indicate a new legal entity include:

- The formation of a new limited company.
- A change to a limited company from a partnership or sole proprietor.
- Transfer of quota to a person or persons not in the existing business or partnership.

## 3. Levy liability

Completion of form MQ/33 will transfer to the new name or partners the liability to pay any overquota levy which is or becomes due.

#### 4. Permanent conversion of quota

Any restrictions in place following the permanent transfer of quota will continue to apply eg or to the Quota Holder following a change of trading title.

## 5. Signatures

All those who were partners in the business under the old trading title must sign Part A. All those who are partners under the new title must sign Part C. If there is not enough space, please attach a separate sheet.

Where a representative is signing on behalf of someone, a power of attorney or letter of authority will be required.

Where the old quota holder is forming a new partnership, the full names and addresses of all partners must be attached on a separate sheet.

## 6. Documentary proof

Where the quota holder is amending the name of an existing limited company, a copy of the Certificate of Incorporation, showing the change of name, must be returned with form MQ/33.

Where the quota holder is changing their name, please supply copies of supporting documents.

Where one member of a partnership has died, the personal representative must sign on behalf of the deceased and supply:

a copy of the death certificate or grant of probate or grant of letters of administration.
