

NOTICE OF ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981

SECTION 53

Lancashire County Council
Definitive Map and Statement of Public Rights of Way
(Definitive Map Modification) (No. 3) Order 2012

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **10 May 2016**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement of Public Rights of Way for the area, by adding a Public Footpath from a point between 56 and 58 St Clements Avenue (Point A at grid reference SD 5517 2329) for a distance of approximately 75 metres to a point between 33 Bristol Avenue and Clifton Parade (Point H at grid reference SD 5516 2325).

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 24 May 2016]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the

applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 05 July 2016]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.


Within 14 weeks of the start date [by 16 August 2016]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

THE LANCASHIRE COUNTY COUNCIL DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS OF WAY (DEFINITIVE MAP MODIFICATION) (NO.3) ORDER 2012

This Order is made by Lancashire County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act, 1981 ("the Act") because it appears to that Authority that The Definitive Map and Statement of Public Rights of Way for the County of Lancashire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) namely the discovery by the Surveying Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, namely a public footpath.


The Authority has consulted with every local authority whose area includes the land to which the Order relates. Lancashire County Council hereby orders that:

1. For the purposes of this Order, the "relevant date" is the 15th February 2012.
2. The Definitive Map and Statement of Public Rights of Way for the County of Lancashire shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Lancashire County Council Definitive Map and Statement of Public Rights of Way (Definitive Map Modification) (No.3) Order 2012.

SCHEDULE

PART I

MODIFICATION OF THE DEFINITIVE MAP

DESCRIPTION OF PATH TO BE ADDED

A Public Footpath from a point between 56 and 58 St Clements Avenue at grid reference SD 5517 2329 running on an enclosed tarmac path in a generally south-west direction for approximately 20 metres to SD 5516 2327. The path continues in a south-south-east direction for approximately 15 metres to a point where the path exits the enclosed passageway and meets the car park at the rear of the Spar shop at SD 5516 2325. The path turns west-south-west for a distance of approximately 10 metres to the north-west corner of the car park to the rear of the Spar Shop at SD 5516 2325 and then in a south-south-east direction for approximately 30 metres past a private metal step structure and gatepost to terminate at Bristol Avenue at SD 5516 2322, a total distance of approximately 75 metres and shown as bold broken lines marked A-B-C-D-E-F-G-H on the attached plan.

PART II

MODIFICATION OF DEFINITIVE STATEMENT

VARIATION OF PARTICULARS OF PATH OR WAY

"Public Footpath 29 from its junction with St Clements Avenue, between 56 and 58 St Clements Avenue, at SD 5517 2329 running on an enclosed tarmac path in a generally southerly direction for 35m, turning west-south-west along the edge of a car park for 10m then south for 30m to terminate at Bristol Avenue at SD 5516 2322 between 33 Bristol Avenue and the properties of Clifton Parade. (All distances, in metres, and compass directions are approximate).

Total length is 75 metres.

Width as follows:


Between St Clements Avenue and the lamp-post (SD 5517 2329 and SD 5516 2327) the width is 1.6 metres.

Between the lamp-post and the northern edge of the car park (SD 5516 2327 and SD 5516 2325) the width is 1.3 metres.

Along the northern edge of the car park the width is 2 metres.


Along the western side of the car park to Bristol Avenue (between SD 5516 2325 and SD 5516 2322) the width is 4 metres.

There are no limitations on the footpath."
