

NOTICE OF PROPOSAL TO MODIFY PUBLIC PATH ORDER  
HIGHWAYS ACT 1980

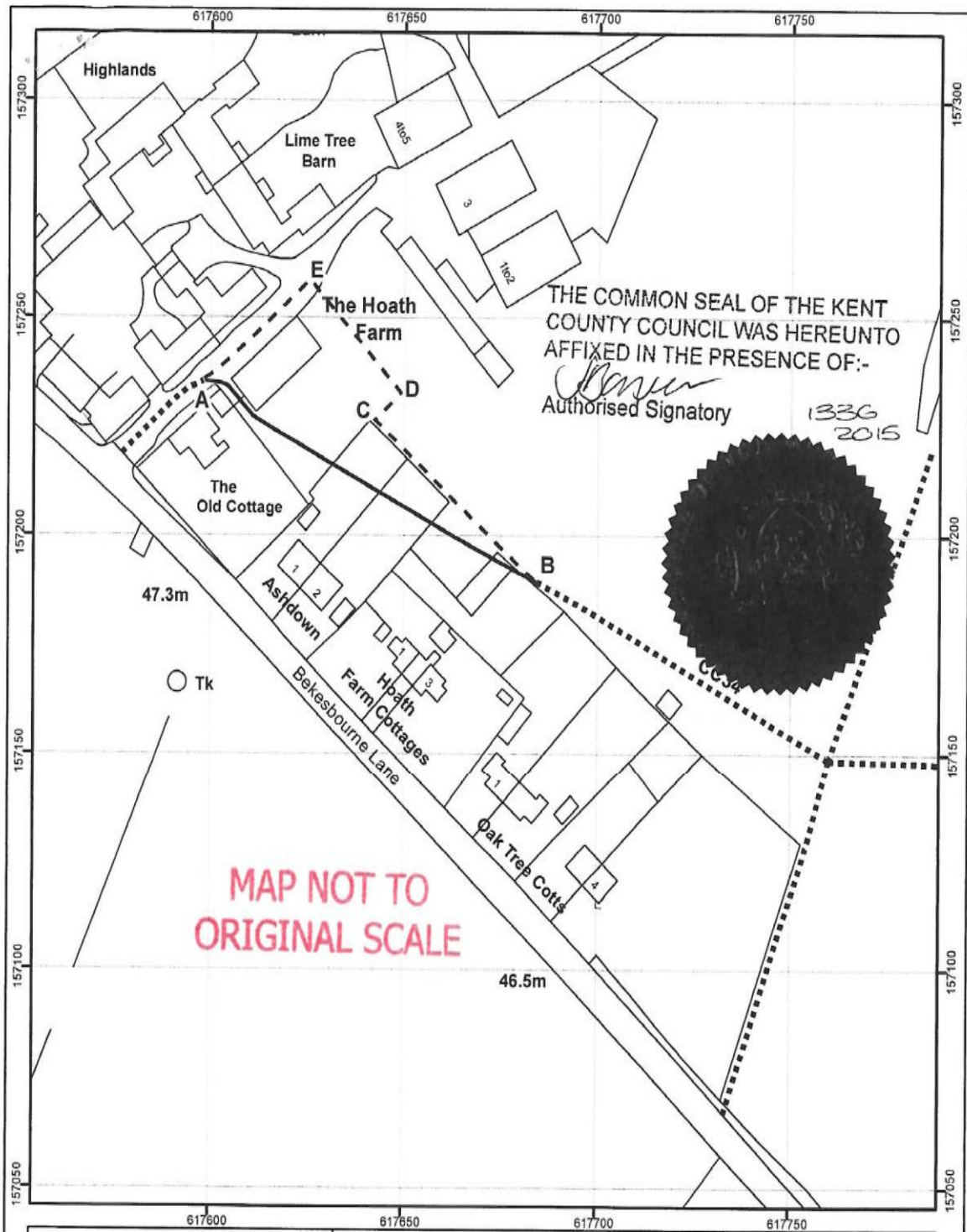
Notice is hereby given pursuant to paragraph 2(3) of Schedule 6 to the Highways Act 1980 that the Inspector appointed by the Secretary of State for Environment, Food and Rural Affairs to determine the Kent County Council (Public Footpath CC34 (Part) Canterbury) Public Path Diversion Order and Definitive Map and Statement Modification Order 2015 proposes to modify the order by providing for the following modifications.

- At paragraph 1 of the Order delete 'seven' and insert 'twenty eight'.
- At Part II of the Schedule to the Order from line 8 delete 'measured one metre to the north east of the existing boundary, for approximately 54 metres, to then turn for 1 metre in a generally south south easterly direction' and insert 'following the north eastern side of the fence-line for approximately 55 metres'.
- At page 2 of the duplicate Order at the end of the first line insert '11<sup>th</sup>'.

A copy of the order as submitted and a copy of the order showing the proposed modification together with the Inspector's Order decision dated 28 April 2016 have been deposited at 1) The Offices of Canterbury City Council, Military Road, Canterbury and 2) Kent County Council, (Growth Environment & Transport), Invicta House, County Hall, Maidstone, Kent ME14 1XX and may be inspected free of charge during normal working hours.

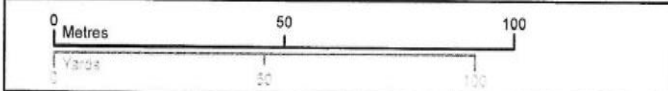
