

MOD Compensation Claims Financial Year 2014/15

Published 9 June 2016

This bulletin relates to claims brought against the Ministry of Defence for compensation at common law (other than those arising out of contract disputes). These are dealt with by the Claims Unit within the Department's Directorate of Judicial Engagement Policy (DJEP), by contractors operating in accordance with instructions provided by the Claims Unit, or by delegated authorities¹.

Key Points

- Total payments by MOD for compensation claims and associated costs in Financial Year 14/15 (not including those arising out of contract disputes) were **£85.1M**. This does not include MOD legal costs which totalled £11.8M exclusive of staff costs. Over the same period recoveries totalling around **£1.6M** were made.
- The highest value claim that was settled on all costs in 14/15 was for clinical negligence. The total value of this claim (damages and claimants' costs) was just under £2.4M.
- The total number of new claims brought against MOD was **5814**. This represents a decrease of around 15% compared with 13/14.
- **1898** Service Personnel Employer's liability claims were settled in 14/15. In-year expenditure² on Service Personnel Employer's liability claims was just under **£52M**.
- **336** Civilian Employer's Liability claims were settled in 14/15. In-year expenditure on Civilian Employer's liability claims was around **£15M**.
- **1400** Public Liability claims were settled in 14/15, of which 1154 were third party motor claims in the UK. In-year expenditure on Public Liability claims was just under **£8M** of which **£4.5M** was accounted for by motor claims.
- 21 Clinical Negligence claims were settled in 14/15. In-year expenditure on Clinical Negligence claims was £5.8M.
- The in-year expenditure on structured settlements/periodic payments was just under £2.9M.
- 681 claims were settled by delegated authorities¹ in 14/15. The in/year expenditure for delegated authorities was £1.4M with recoveries in excess of £218,000.

Introduction

When compensation claims are received they are considered on the basis of whether or not the Ministry of Defence has a legal liability to pay compensation. A payment of compensation in circumstances where the Department does not consider that a court would find it liable would count as an ex gratia payment, and the Department is not empowered to make such payments without Treasury authorisation, which is rarely sought or given. The only exceptions to this rule relate to claims arising from low flying and to certain claims settled in theatre by Area Claims Officers.

The amount of compensation paid is determined by common law principles which broadly take account, as appropriate, of such factors as an individual's pain and suffering, degree of injury, property losses, past and future financial losses and level of care required. Advice is sought where necessary from the Government Legal Department, and the Department's commercial claims handlers' panel solicitors for cases brought in England and Wales; the Crown Solicitor in Northern Ireland; and Morton Fraser Solicitors, the Department's legal adviser in Scotland. Counsel are also consulted on high profile or complex cases or where a point of law needs to be explored. The majority of cases are settled through negotiation in order to save the parties the additional costs of a court appearance. This bulletin does not distinguish between compensation ordered by a court and compensation paid pursuant to a negotiated settlement.

Section 1 Compensation claims made against the MOD

The total number of new claims brought against MOD in 14/15 was 5814. This represents a decrease of around 15% compared with 13/14. There has been a significant reduction in the area claims office in Afghanistan where claims have dropped as a result of the withdrawal of troops from the area (399 claims received in 13/14 compared to 33 in 14/15). There has also been a fall in the number of claims received for noise-induced hearing loss cases, although it still remains the most commonly claimed for condition in the employer's liability claims category. The number of Public Liability claims peaked in 13/14 owing to the large number of Iraq Civilian Litigation claims (617). In 14/15 189 Iraq Private Law Public Liability claims have been served.

Section 2 Settled compensation claims notified

In this Section, the term settled means claims that were fully determined. In total 3655 claims were settled on all costs in 14/15 either out of Court or by Court verdict. The financial year in which settlement is recorded is not necessarily the year in which the damages were paid. This category does not include any discontinuances, strikeouts via the Courts or repudiations by the Claims Unit or by delegated authorities.
