This NAA covers amendments to the ATM MRP (RA 3261 and RA 3274) based upon changes to Standardised European Rules of the Air (SERA) and CAA Exemptions, Requests for Change (RFC) from the Regulated Community and routine review.

## Amplification:

RA 3261 - Aerodrome Services. The most significant amendments cover:

- 1. Simplification of wording of VFR and Special VFR Class D operations in line with Standarised European Rules of the Air (SERA) and associated CAA Exemptions (paragraphs 11-12).
- 2. Cross referencing with RA 2307 Rules of the Air and CAA General Exemption from SERA detailing reduced VMC minima in Class D Airspace (paragraph 7-14).
- 3. Expansion of AMC regarding when controllers should warn pilots of gusts or crosswinds (paragraph 18).
- 4. Inclusion of AMC and GM on Provision, Delivery and Content of Automatic Terminal Information System (ATIS) (paragraph 19-21, 49).

RA 3274 - Low Visibility Procedures.

- 1. Clarified for implementation of LVP, including a military varience less stringent than civilian operations (paragraph 3-6).
- 2. Expansion of the GM regarding Visibility Condition 2, Visibility Condition 3 and Enforcement of Positive

Control Measures (paragraph 9).

- 3. Inclusion within GM of the use of Stop-Bar Lighting and Runway Guard Lights (paragraph 14-15).
- 4. Inclusion within GM of the Definitions of: Aerodrome Incursion, Runway Incursion, Protected Areas, Category I and II Operations (paragraph 16-18).
