Policy refresh: indicators for 2016 to 2019

The Public Health Outcomes Framework was refreshed in May 2016, following a consultation in 2015. This update is the first publication of data on the new framework. Additional indicators will be added as they become available. Details of the new framework can be found in the [government response to the consultation](#).

* Note: The smoking prevalence indicators that were based on the Integrated Household Survey (IHS) have been discontinued and replaced with new indicators based on the Annual Population Survey (APS). The IHS was a composite survey combining questions asked on a number of ONS social surveys to produce a dataset of 'Core' variables. The aim of the IHS was the production of high-level estimates for particular themes to a higher precision and lower geographic level than previous ONS social surveys. The APS was the largest of the surveys included and formed the core of the IHS. Over time the other modules were dropped to leave, from 2015, a dataset solely based upon the APS. Therefore ONS announced it would no longer produce IHS branded or IHS specific products. Instead the questions formerly regarded as the IHS core will continue to be asked in, and output data be provided by the APS. Some differences in survey coverage, imputation and weighting methodology may result in some small discontinuity for certain 'core' variables compared to estimates previously provided as part of the IHS. We have provided data from the APS reweighted back to 2012 to give a time series for the new indicators. The IHS indicators will be kept on the LTCP but will not be updated and should not be directly compared with the APS.
