I am directed by the Secretary of State for Environment, Food and Rural Affairs to refer to the above named Order, which was submitted to him for confirmation on 23 June 2016.

Examination of the Order and map has revealed that the Order has been incorrectly drafted. The Order is not substantially in the format laid down within the Town and Country Planning (Public Path Orders) Regulations 1993 (SI 1993 No. 10) in that the incorrect notation has been used to depict the footpaths to be diverted/added. You have used a bold green line to show the routes to be diverted as opposed to a bold black line and you have used red dashed lines to show the alternative sections of footpath rather than bold black dashes. Also paragraph 4(1), a public path order shall be made in duplicate. It is my understanding that only one order was made.

As a separate issue, it should be noted that the use of red is reserved for the use of Inspectors to show modifications that have been made to an Order.

The Secretary of State takes the view that this constitutes a fundamental error which is fatal to the validity of the Order. As he cannot purport to use his power of modification to correct such an error, he has decided not to exercise his power of confirmation. The sealed Order is returned herewith and a copy of this letter has been sent to the objectors and all other interested parties.

This order ("Order") is made by Stafford Borough Council under section 257 of the Town and Country Planning Act 1990 because it is satisfied that —

- a) An application for planning permission has been made under Part 3 of the Act, namely 14/21163/FUL, single storey extension to the rear of Blacklake Lodge Residential Home to provide an additional 10 no. bedrooms for specialist dementia care.
- b) As the application has been granted, it is necessary to authorise the diversion of the footpath to which this Order relates in order to enable development to be carried out.


