

NOTICE OF ORDER

HIGHWAYS ACT 1980 SECTION 119

Essex County Council
Public Path Diversion Order 2016
Footpath 13 Wickham Bishops in the District of Maldon

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 14 September 2016.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert a part length of public Footpath 13 Wickham Bishops in the District of Maldon as shown on the Order map contained in this Order. The definitive line of Footpath 13 runs directly across the middle of the field and the proposal is to divert it further south away from the residence known as Ballards.

A part length of Footpath 13 Wickham Bishops starting from a point just to the south east of Wickham Hall Lane at grid reference 5831,21186 and running in a south easterly direction across the field for a distance of 190 metres to grid reference 58374,21173 just to the north west of the highway known as Grange Road will be diverted to a new alternative route 2 metres in width commencing at the same above point and running in a southerly direction across the field for a distance of 57 metres to grid reference 58361,21181 and then running in a south easterly direction for a distance of 117 metres to grid reference 58369, 21173 and finally in an easterly direction across the field for a distance of 47 metres to same above point where it continues unaffected.

Any person wishing to view the statements of case and other documents relating to this Order may do so by appointment at The Definitive Map Service Department, A2 Seax House, County Hall, Market Road, Chelmsford, Essex CM1 1QH during normal office working hours.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 28 September 2016]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 9 November 2016]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 21 December 2016]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

We cannot accept any libellous, racist or abusive comments. Any documents containing such comments will be returned.

This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the right of way should be diverted.

The landowners will defray all costs which are incurred in bringing the new site of the path into a fit condition for use by the public




Maldon District Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

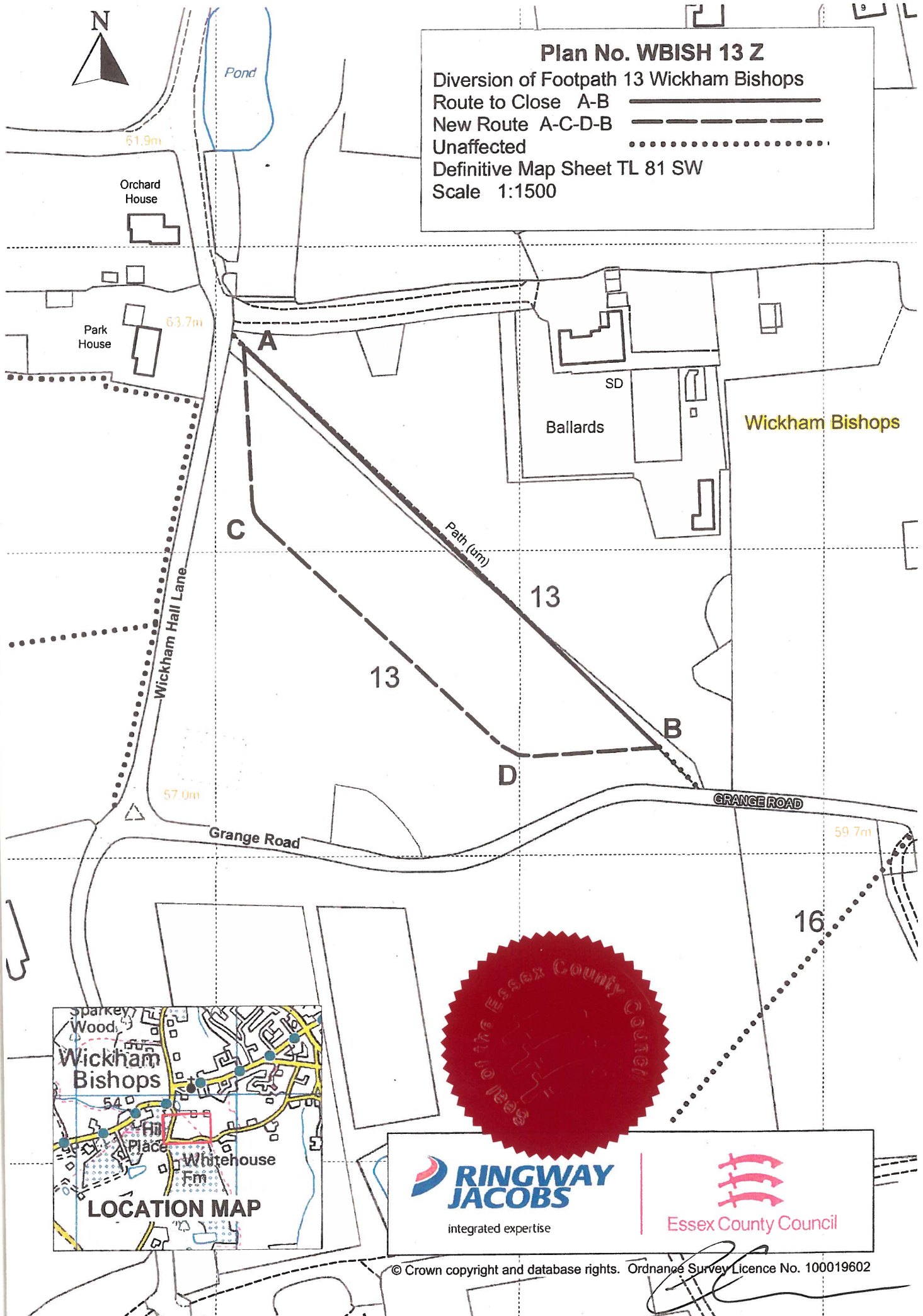
BY THIS ORDER:

1. The public right of way known as Footpath 13 over the land situated at the property known as Ballards in the Parish of Wickham Bishops in the District of Maldon and shown by a black bold continuous line on the plan numbered WBISH 13Z contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 35 days from the date of confirmation of this Order.

2. At the end of 28 days from the date of confirmation of this Order there shall be a public footpath over the land situated at Ballards in the Parish of Wickham Bishops in the District of Maldon described in Part 2 of the Schedule and shown by a bold broken line on the plan numbered WBISH 13Z contained in this Order.

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 13 Wickham Bishops of undefined width and shown by a bold black continuous line on the Order Map starting from point **A** just to the south east of Wickham Hall Lane at grid reference 5831,21186 and running in a south easterly direction across the field for a distance of 190 metres to point **B** at grid reference 58374,21173 just to the north west of the highway known as Grange Road



DESCRIPTION OF SITE OF NEW PATH OR WAY

A Footpath being 2 metres in width shown by a bold black broken line on the Order Map commencing at the aforementioned point **A** and running in a southerly direction across the field boundary for a distance of 57 metres to point **C** at grid reference 58361,21181 and then running in a south easterly direction for a distance of 117 metres to point **D** at grid reference 58369,21173 and finally in an easterly direction across the field for a distance of 47 metres to the aforementioned point **B**.
