Statement of BFC's Vetting Policy

In the interests of national security, safeguarding MOD interests and maintaining the proper security of the British Forces Cyprus' essential activities, it is policy of that no one should be afforded entry into its establishments who:

- f* is or has been, involved in, or associated with any of the following activities:
 - f* Espionage,
 - f* Terrorism,
 - f* Sabotage,
 - f* Actions intended to overthrow or undermine Parliamentary democracy by political, industrial or violent means,
 - f* Serious Crime; or
- f* is, or has recently been:
 - f* A member of any organisation which has advocated such activities; or
 - f* Associated with any such organisation, or any of its members in such a way as to raise reasonable doubts about his or her reliability; or
 - f* Is susceptible to pressure or improper influence, for example because of current or past conduct; or
 - f* Has shown dishonesty or lack of integrity which throws doubt upon their reliability; or
 - f* Has demonstrated behaviour or is subject to circumstances which may otherwise indicate unreliability.

It is a control of entry policy that persons wishing to obtain permanent, unescorted access to BFC establishments prove they have a history of good conduct. This is achieved by producing a Criminal Records Check (CRC). BFC reserves the right to validate any CRC with the appropriate authorities. The purpose of such checks is to prevent those who may have connections with terrorist or criminal organisations, or who may be vulnerable to pressure from such organisations, from gaining access to BFC establishments.

Failure to disclose relevant circumstances or information is likely of itself to be regarded as evidence of unreliability and will be taken into account in assessing your suitability for a Veterans access pass. It is therefore in your interest to be honest and open in your replies to the questions.

BFC complies with the Data Protection Act 1998. All information received will be kept in the strictest confidence. Information is only released to third parties under strict controls and in accordance with the law. Information may only be provided to a third party if further enquiries are considered necessary.
