WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

Hertfordshire County Council (Barkway 5, 27 and Reed 24) Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 4 November 2016.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will modify the Definitive Map and Statement for the area by:-

Adding a bridleway commencing at a junction with Reed BR 9 at TL 3714 3567 (point D of the Order Plan) running generally west for approximately 15 metres to TL 3713 3568 (point E on the Order Plan) then north for approximately 270 metres through Bush Wood to a junction with Barkway BOAT 2 and Reed 10 at TL 3709 3595 (point F on the Order Plan), and

Adding to the particulars relating to the Barkway bridleway 5 from points A to C and Reed bridleway 9 from points C to D of the Order Plan by defining the width as varying between 4m and 9m between TL 3783 3540 and TL 3714 3567 as shown in the Hertfordshire County Council (Barkway 5, 27 and Reed 24) Modification Order 2016.

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 30 December 2016]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 10 February 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties <u>everyone should keep to the</u> <u>timetable</u> to ensure that statements of case and comments are received on time. Late documents will be returned.

WILDLIFE AND COUNTRYSIDE ACT 1981

The Definitive Map and Statement of Public Rights of Way in Hertfordshire

Hertfordshire County Council (Barkway 5, 27 and Reed 24) Modification Order 2016

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3) (c)(i) & (iii) of the Act, namely (c) the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows

(i) that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic; and (iii) that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

- 1. For the purposes of this Order the relevant date is 5 February 2016.
- 2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
- This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Barkway 5, 27 and Reed 24) Modification Order 2016.


