

NOTICE OF ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981

SECTION 53

Staffordshire County Council
(Public Footpath from A518 Weston Parish to A518 Amerton, Stowe-by-
Chartley Parish) Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 9 January 2017.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will modify the Definitive map and statement for the area by adding a length of Public Footpath commencing from the field gate at its junction with the A518 at a point approximately 500 metres southwest of Wadden Farm, Point A on the Order Plan (398066 327481) and running in a generally east north easterly direction for approximately 388 metres to a new bridge, Point B on the Order Plan (398432 327565) continuing in a generally easterly direction for approximately 373 metres to a new stile, Point C on the Order Plan (398792 327632) continuing in a generally easterly direction for approximately 84 metres to a new stile, Point D on the Order Plan, (398874 327622) continuing in a generally easterly direction for approximately 128 metres to an existing field gate, Point F on the Order Plan (399134 327629) continuing in a generally north easterly direction for approximately 148 metres to its terminus at the field gate at the junction with the A518 opposite Amerton Farm, Point G on the Order Plan (399226 327741)

Timetable for sending in statements of case and comments

Within 2 weeks of the start date 23 January 2017

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date 6 March 2017

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date 17 April 2017

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by Staffordshire County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Secretary of State for Environment Food and Rural Affairs (who has directed the authority to that effect) that the Definitive Map and Statement for the District of Stafford Borough require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority has consulted with every local authority whose area includes the land to which the order relates. The Staffordshire County Council hereby order that:


1. For the purposes of this order the relevant date is the date that it is made.
2. The definitive map and statement for the District of Stafford Borough shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Staffordshire County Council (Public Footpath from A518 Weston Parish to A518 Amerton, Stowe-By-Chartley Parish) Modification Order 2016.

A length of Public Footpath commencing from the field gate at its junction with the A518 at a point approximately 500 metres southwest of Wadden Farm, Point A on the Order Plan (398066 327481) and running in a generally east-northeasterly direction for approximately 388 metres to a new bridge, Point B on the Order Plan (398432 327565) continuing in a generally easterly direction for approximately 373 metres to a new stile, Point C on the Order Plan (398792 327632) continuing in a generally easterly direction for approximately 84 metres to a new stile, Point D on the Order Plan (398874 327622) continuing in a generally easterly direction for approximately 139 metres to an existing field gate, Point E on the Order Plan (399007 327619) continuing in a generally easterly direction for approximately 128 metres to an existing field gate, Point F on the Order Plan (399134 327629) continuing in a generally northeasterly direction for approximately 148 metres to its terminus at the field gate at the junction with the A518 opposite Amerton Farm, Point G on the Order Plan (399226 327741).

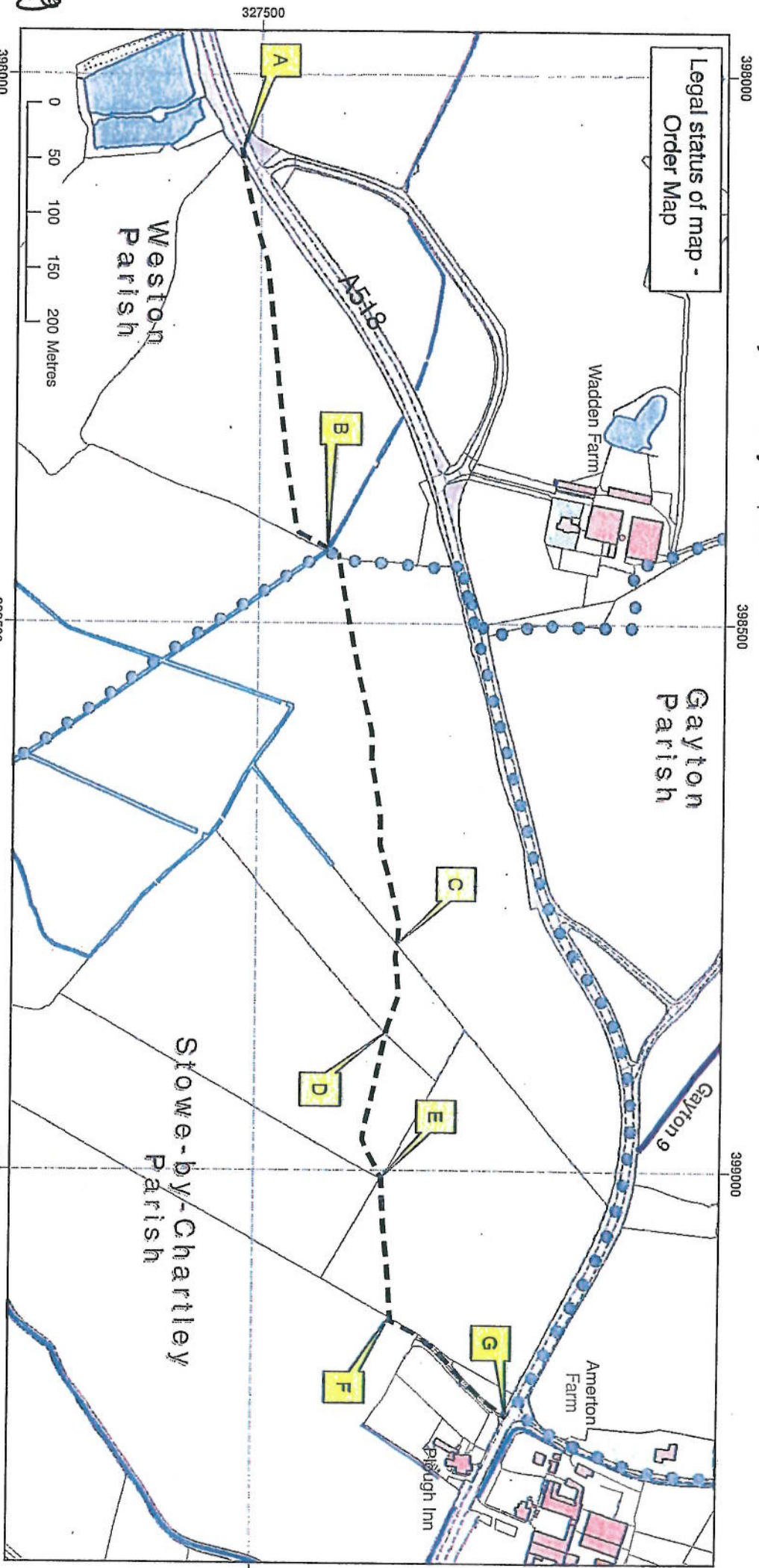
