

# NOTICE OF ORDER

## HIGHWAYS ACT 1980 SECTION 119

Warwickshire County Council  
(Part of footpath SD29a Clifford Chambers and Milcote) Public Path  
Diversion Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **3 January 2017**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the above Order, if confirmed without modifications will be to **DIVERT** that section of Public Footpath SD29a commencing at Point A (grid ref 41866 25322) passing under the Stratford Greenway and running generally south west for approximately 715 metres to Point B (grid ref 41806 25298) as shown on the Order Plan. **TO A LINE** following a metalled path from Point A (grid ref 41866 25322) north west to Point C (grid ref 41868 25324), then south west along the Stratford Greenway to Point D (grid ref 41810 25298), then west to Point B (grid ref 41806 25298) as shown on the Order Plan, a total distance of approximately 705 metres. The new route shall have a width of 1.4 metres between Points A-C, 2 metres between Points C-D and 1.2 metres between Points D-B.

### **Timetable for sending in statements of case and comments**

#### **Within 2 weeks of the start date [by 17 January 2017]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to

everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

**Within 8 weeks of the start date [by 28 February 2017]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

**Within 14 weeks of the start date [by 11 April 2017]**

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

PUBLIC PATH DIVERSION ORDER 2016**

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the public the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Stratford-on-Avon District Council has been consulted as required by section 120(2) of the 1980 Act;

**BY THIS ORDER:**

1. The public right of way over the land situate at **Clifford Chambers and Milcote** and shown by a bold continuous line on the plan numbered P2016/001G contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up upon the issue by the authority of a written certificate that all works to implement the Order have been satisfactory completed.
2. There shall upon confirmation and the issue by the authority of a written certificate that all works to implement the Order have been satisfactory completed be a public footpath over the land situate at **Clifford Chambers and Milcote** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

**PART 1**

**DESCRIPTION OF SITE OF EXISTING PATH OR WAY  
Between Points A and B on the Order Plan**

That section of Public Footpath SD29a commencing at Point A (grid reference 41866 25322) passing under the Stratford Greenway and running generally south west for approximately 715 metres to Point B (grid reference 41806 25298) as shown on the Order Plan.

**PART 2**

**DESCRIPTION OF SITE OF NEW PATH OR WAY  
Between Points A-C-D and B on the Order Plan**

Following a metalled path from Point A (grid reference 41866 25322) north north west to Point C (grid reference 41868 25324), then south west along the Stratford Greenway to Point D (grid reference 41810 25298), then west to Point B (grid reference 41806 25298) as shown on the Order Plan, a total distance of approximately 705 metres.

The new route shall have a width of 1.4 metres between Points A-C, 2 metres between Points C-D and 1.2 metres between Points D-B.
