

NOTICE OF ORDER

Borough of Charnwood H61 (Part) at Rempstone Road, Wymeswold Public
Path Diversion Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 14 February 2017.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert (part) of the existing bridleway from Point A (OS Grid Ref. 45992, 32362) for 114m in a northerly direction to Point C (OS Grid Ref. 45995, 32373). A replacement bridleway will extend from Point A (OS Grid Ref. 45992, 32362) for 42m in a north westerly direction to Point D (OS Grid Ref. 45990, 32366), then from Point D (OS Grid Ref. 45990, 32366) for 49m in north easterly direction to Point B (OS Grid Ref. 45993, 32369) and then from Point B (OS Grid Ref. 45993, 32369) for 44m in northerly direction to Point C (OS Grid Ref. 45995, 32373).

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 28 February 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 11 April 2017]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 23 May 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

PUBLIC PATH DIVERSION ORDER 2016

This Order is made by Charnwood Borough Council ('the Council') under section 257 of the Town and Country Planning Act 1990 because it is satisfied that it is necessary to divert the footpath to which this Order relates in order to enable the development to be carried out in accordance with outline planning permission granted on appeal dated 27th August 2013 and a grant of reserved matters dated 28th August 2015 under the Town and Country Planning Act 1990. The planning permission is for the erection of 31 dwellings at land north of Rempstone Road, Wymeswold. Further detail is provided in the planning applications registered by the Council under its references P/12/3117/2 and P/15/0217/2.

BY THIS ORDER:

1. That part of the bridleway over the land situated in the Parish of Wymeswold as is shown by a solid black line on the map contained in this Order and further described in Part 1 of the Schedule to this Order ('the Schedule') shall be diverted seven days from when the Council certifies that Article 2 of this Order has been complied with.
2. There shall be created for public use as an alternative highway to the reasonable satisfaction of the Council before the date of confirmation of this Order a replacement bridleway over land situated in the Parish of Wymeswold described in Part 2 of the Schedule and shown by a broken line on the Plan contained in this Order.
3. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule:
 - (a) the proposed new route between shall be to a width of at least 3 metres.
 - (b) the proposed new route shall have a finger posts at point A as shown on the attached plan.
4. Where immediately before a date on which the bridleway is diverted there is apparatus under in on over along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of apparatus as they then had.


Charnwood Borough Council Public Bridleway Diversion Order 2016 Bridleway H61 (part)
