

NOTICE OF ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981

SECTION 53

Cambridgeshire County Council
(Public Bridleway No 20 Warboys) Definitive Map Modification Order 2013

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 27 February 2017.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **Warboys Parish Centre, High Street, Warboys PE28 2TA** on **Tuesday 1 August 2017** at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the area by upgrading part of Public Footpath No.8 Warboys to part of Public Bridleway No.20 Warboys starting from Fenside Road at Ordnance Survey Grid Reference TL 3303 8182 and running in a generally southerly direction for 245m to OS GR TL 3306 8158 and by adding part of Public Bridleway No.20 Warboys starting from OS GR TL 3306 8158 and running in a generally easterly direction for 145m to OS GR TL 3320 8158, turning to skirt a pond at the corner of the field and running in a generally southerly direction for 200m, crossing the former line of Heath Road, to OS GR TL 3323 8139 where it meets the boundary of the re-aligned Heath Road.

Timetable for sending in statements of case and proofs of evidence

Within 8 weeks of the start date [by 24 April 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 5 June 2017]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

4 weeks before the date of the inquiry [by 4 July 2017]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence).

All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.

The Definitive Map and Statement of Public Rights of Way for the former County of Huntingdonshire dated 9th September 1953 as reviewed at 14th December 1961

The Cambridgeshire County Council (Public Bridleway No.20 Warboys) Definitive Map Modification Order 2013

This Order is made by Cambridgeshire County Council under section 53 (2) (b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the former County of Huntingdonshire dated 9th September 1953 as reviewed at 14th December 1961 require modification in consequence of the occurrence of an event specified in section 53 (3) (c) (i) & (ii) of the Act, namely the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist, and which shows that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description.

The Authority have consulted with every local authority whose area includes the land to which the Order relates. The Cambridgeshire County Council hereby order that:

1. For the purposes of this Order the relevant date shall be the date on which this Order is made.
2. The Definitive Map and Statement of Public Rights of Way for the former County of Huntingdonshire dated 9th September 1953 as reviewed at 14th December 1961 shall be modified as described in the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Cambridgeshire County Council (Public Bridleway No.20 Warboys) Definitive Map Modification Order 2013



Position of path as indicated on the plan	Description	Width
A-B	Part of Public Footpath No.8 Warboys to be upgraded to Public Bridleway No.20 Warboys. Starts on Fenside Road at Ordnance Survey Grid Reference TL 3303 8182 (Order Map point A) and runs in a generally southerly direction for 243m to OSGR TL 3306 8158 (Order Map point B).	4 metres
B-C-D E-F	Part of Public Bridleway No.20 Warboys to be added. Starts at OSGR TL 3306 8158 (Order Map point B) and runs in a generally easterly direction for 145m to OSGR TL 3320 8158 (Order Map point C), then turns to skirt a pond at the corner of the field and to run in a generally southerly direction for 170m to OSGR TL 3323 8141 (Order Map point D) where it meets the northern boundary of the former line of Heath Road. The bridleway continues from the southern boundary of the former line of Heath Road at OSGR TL 3323 8140 (Order Map point E) in a southerly direction for 8 metres to OSGR TL3323 8139 (Order Map point F) where it meets the boundary of the re-aligned Heath Road	4 metres 4 metres

PART II
Modification of Definitive Statement

Public Bridleway No.20, Warboys starts from a point on Fenside Road at Ordnance Survey Grid Reference TL 3303 8182 and runs in a generally southerly direction for 245m to OS GR TL 3306 8158 where it turns to continue in a generally easterly direction for 145m to OS GR TL 3320 8158, then turns to skirt a pond at the corner of the field and to run in a generally southerly direction for 170m to OSGR TL 3323 8141 where it meets the northern boundary of the former line of Heath Road. The bridleway continues from the southern boundary of the former line of Heath Road at OSGR TL 3323 8140 in a southerly direction for 8 metres to OSGR TL3323 8139 where it meets the boundary of the re-aligned Heath Road. Width 4m.

Public Footpath No.8 Warboys starts from a point on Public Bridleway No.20 Warboys at Ordnance Survey Grid Reference TL 3306 8158 and runs in a southerly direction to its termination on Heath Road west of Woolvey Farm.
