Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **18 April 2017**
Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications will be to extinguish part of Megaloughton Lane, Spondon, from Point A on the order map at SK439134 335284 in a north easterly direction to Point B on the order map at SK439166 335313.

Any person wishing to view the statements of case and other documents relating to this Order may do so by appointment at the Council House, Corporation Street, Derby, DE1 2FS between the hours of 8.30am to 5.00pm on Mondays to Fridays.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [02 May 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after receiving it the Secretary of State will send a copy to everyone who has made an objection or representation, the applicant and any other person who has made a written representation.

Within 8 weeks of the start date [13 June 2017]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the

above date the Secretary of State will send copies to the Authority, the applicant, every other person who has made an objection or representation and any other person who has made a written representation.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after receiving it the Secretary of State will send a copy to the Authority, everyone who has made an objection or representation and any other person who has made a written representation.

Within 14 weeks of the start date [25 July 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has made a written representation must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

EXTINGUISHMENT ORDER 2014

This Order is made by the Derby City Council ("the authority") under Section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

BY THIS ORDER

1. The public right of way over the land shown by the continuous bold line on Plan 1 contained in this Order and described in Part 1 of the Schedule of this Order shall be extinguished after 365 days from the date of the confirmation of this order.

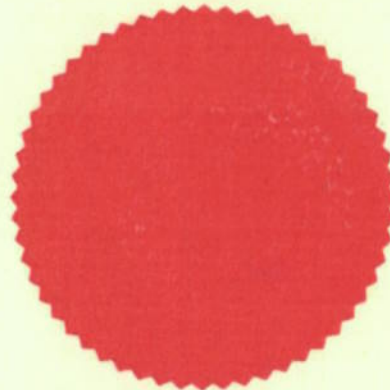
PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

That part of Megaloughton Lane commencing from Point A (grid reference SK439134 335284) for a distance of 45 metres in a north easterly direction to Point B (grid reference SK439166 335313) as shown on the Order plan. From Point A, at a width of approximately 5 metres, the path narrows to approximately 1 metre across the railway lines where it finishes at Point B.

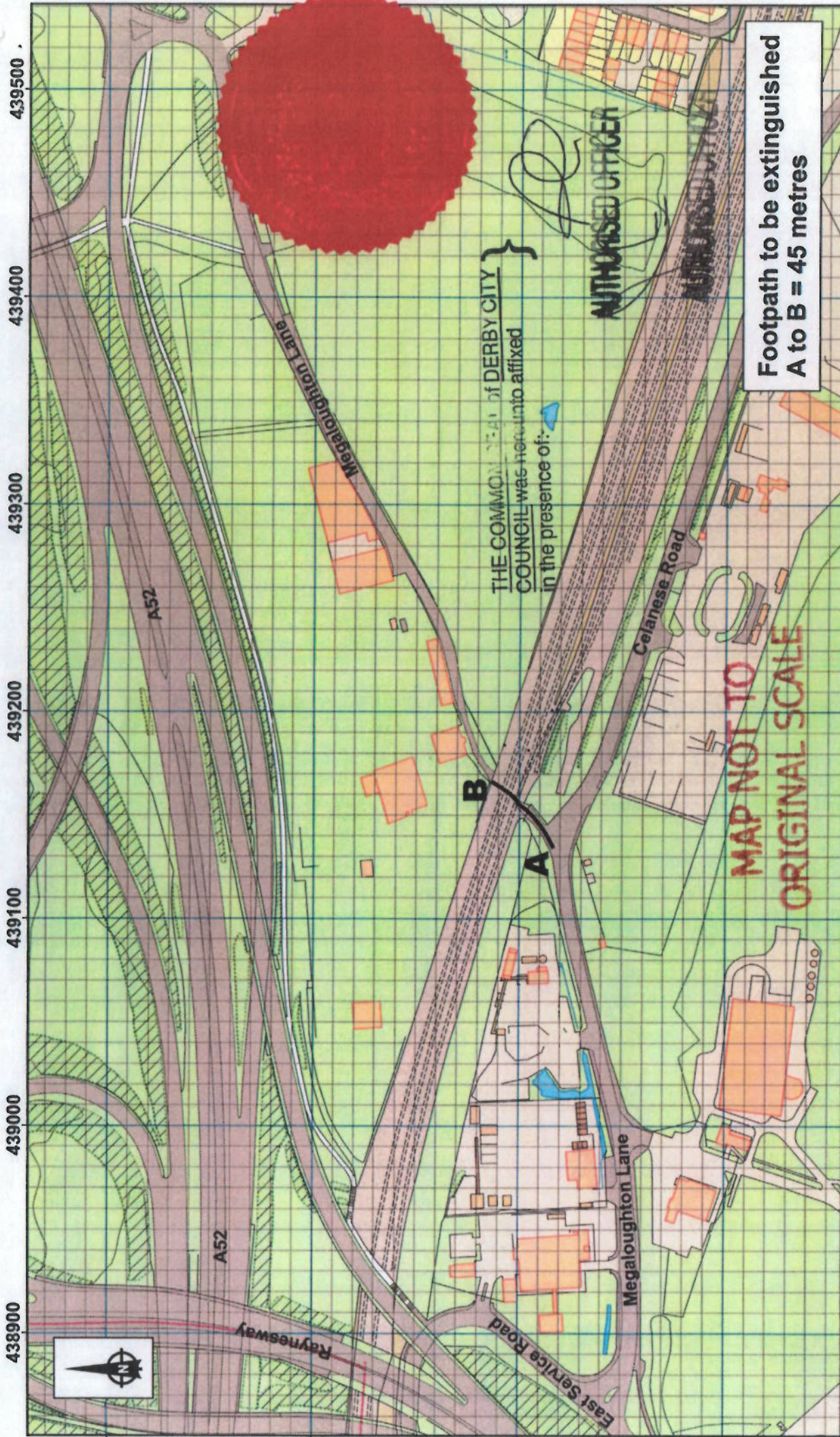
