Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **2 May 2017**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the above Area by adding thereto the footpath commencing from a point at grid reference SK 5763 6316 at the junction with Mansfield Woodhouse Bridleway No. 30 (Clipstone Drive) and proceeding for a distance of approximately 820 metres in a generally north-westerly direction to point SK 5702 6368 (Spa Ponds); then proceeding for a distance of 43 metres in a west-south-westerly direction to a point SK 5698 6366 at the junction with Mansfield Woodhouse Bridleway No. 31 as shown on the Order map.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 16 May 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 27 June 2017]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 8 August 2017]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

THE NOTTINGHAMSHIRE COUNTY COUNCIL (MANSFIELD WOODHOUSE FOOTPATH NO. 58) MODIFICATION ORDER 2016

This Order is made by the Nottinghamshire County Council under Section 53(2)(b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to that Authority that the Nottinghamshire (Mansfield District) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates.

The Authority have consulted with every Local Authority whose area includes land to which the Order relates.

The Nottinghamshire County Council hereby order that:

1. For the purposes of this Order the relevant date is the 11th of March 2016.
2. The Nottinghamshire (Mansfield District) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the Map attached to this Order.
3. This Order shall take effect on the date it is confirmed and may be cited as "The Nottinghamshire County Council (Mansfield Woodhouse Footpath No.58) Modification Order 2016".

Mansfield Woodhouse Footpath No.58

Commencing from a point SK 5763 6316 (point A on the order plan), at the junction with Mansfield Woodhouse Bridleway No.30, proceeding for a distance of approximately 311 metres in a generally north-westerly direction to point SK5738 6333 (point B on the Order plan); then proceeding for a distance of approximately 316 metres in a north-westerly direction to point SK 5716 6356 (point C on the order plan); then proceeding for a distance of approximately 193 metres in a generally north-westerly direction to point SK 5702 6368 (point D on the order plan); then proceeding for a distance of 43 metres in a west-south-westerly direction to a point SK 5698 6366 (point E on the order plan) at the junction with Mansfield Woodhouse Bridleway No.31.

Width: 3.0 metres between SK 5763 6316 (Point A) and SK 5738 6333 (Point B)
1.8 metres between SK 5738 6333 (Point B) and SK 5716 6356 (Point C)
1.0 metre between SK 5716 6356 (Point C) and SK 5702 6368 (Point D)
1.2 metres between SK 5702 6368 (Point D) and SK 5698 6366 (Point E)




Existing recorded bridleway
