- All road vehicles used to transport **Other** species on journeys **over 8 hours into the EU** must be inspected and approved

Further requirements on tracking vehicles apply to transporters of unregistered horses and livestock travelling longer than 12 hours or outside the UK. Transporters are required to demonstrate that they use a satellite tracking system that records details of journeys as set out in the journey logs, plus the opening and closing of the loading flap. Applicants must have a satellite tracking facility in vehicles and applicants must confirm they meet this requirement through declaration H. Further guidance on this aspect is contained within Defra's general guidance on the Regulation.

F. I will inform the office which issued the Authorisation of any changes in the details I have provided on this form within 15 days of those changes occurring and understand that if any information on the Authorisation Certificate changes, the Authorisation Certificate will be revoked and a new one will need to be issued

G. I have sufficient and appropriate staff, equipment and operational procedures to comply with the Regulation and I will only entrust the animals transported in the course of my business to persons who have demonstrated their competence in accordance with the Regulation

H. I confirm that, if I operate or hire vehicles used to transport domestic farm livestock or unregistered horses on either domestic only journeys exceeding 12 hours duration and / or on export journeys exceeding 8 hours duration, these vehicles are fitted with a navigation system, as specified under Annex 1, Chapter VI, 4.1 of the Regulation

I. I understand that all my/our drivers and attendants must have effective contingency plans in case of disruptions to travel or illness and injury of any animal. To this end all drivers/ attendants have; (i) been given instructions on where animals should be taken in case journeys are interrupted or curtailed for any reason, including breakdown, crash road closures, cancellation of ferry crossing etc (ii) sufficient and appropriate feed and liquid is carried both for the intended journey and in case of delays; (iii) instructions on where to seek veterinary care in case animals fall ill or are injured; and (iv) that drivers and attendants will make these contingency plans available to any Inspector of a Competent Authority on request

J. I will ensure a copy of the Authorisation is carried in the vehicle(s) at all times when transporting animals and the Authorisation will be made available to any Enforcement Officer within the United Kingdom or European Union if asked to do so.
