### Fisheries Convention, signed at London, 9 March - 10 April 1964

(with Protocol of Provisional Application and two Agreements as to Transitional Rights)

This Convention entered into force on 15 March 1966.

The Protocol of Provisional Application and the Agreements on Transitional Rights entered into force on 18 March 1964 between the United Kingdom and the Republic of Ireland and subsequently for other States on the date for their signature.

This Convention was published in the UK Treaty Series as No. 35 (1966) and the Protocol was published UK Treaty Series as No 29 (1965).
