1. [FCO Name redacted] and I saw Ayman Asfari – Syrian Businessman [Text Redacted - Section 40] – for a catch up today.

2. I took him through where we were on different tracks. [Text redacted – section 27] There was an intense debate going on about how to deal with Nusra, which had not yet been resolved. There was little sign of progress on the political track [Text Redacted - Section 27]. On the multilateral track, there were some signs that the ISSG threat of airdrops was paying dividends, with the regime now indicating it would accept the UN plan and allow land access to besieged areas. We would keep up the pressure. But it was difficult to see the opposition re-engaging in serious talks until the enabling environment had improved. We had not given up on 1 August as a target date for an agreement, but increasingly it looked like the challenge would be how to use the second half of the year to embed the cessation of hostilities and improved humanitarian access [Text Redacted - Section 27].

6. We talked through various options for launching the plan and I said I would seek your advice. My instinct was that it was better to do this in a tour of key capitals, Washington, London, Paris and Berlin than perhaps Geneva. But I could also see the case for doing this in New York, and than sending the plan to the Security Council. The HNC might launch it publically at a major Washington think tank, [text redacted – section 41], who would be able to drag in all the foreign correspondents. The HNC would need a good team [Text Redacted – Section 27]. I said we would consult and revert to him with collective advice. Views welcome please.

SYRIA: FOREIGN SECRETARY AYMAN ASFARI

1. The Foreign Secretary saw Syrian businessman [Text Redacted – Sections 40] Ayman Asfari on 16 June. They had a long discussion about [Text Redacted – Sections 27] Opposition views and our own thinking. [Text Redacted – Section 41]

3. On launching an opposition vision along these lines the Foreign Secretary told Asfari that he thought this would be a good move tactically, [Text Redacted – Section 27]. The Foreign Secretary asked for a short note on how we might support this. There are two broad options:

- a. Autumn Launch. [Text Redacted Sections 27, 35 & 41]
- b. Go Early. We encourage the Opposition to work to a faster timetable and launch their vision in early July. Early launch would not resolve the fundamental problem, but it would give us something to work with ahead of the proposed ISSG in mid-July and 1 August deadline for a US/Russia agreement on a transition plan.
