Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **10 October 2017**.

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **Combe Martin Community Hall, Church Street, Combe Martin, Devon, EX34 0LQ** on **Tuesday 10 April 2018** at 10.00am.

The effect of the Order, if confirmed without modifications, will be to modify the Definitive Map and Statement for the parish of Berrynarbor in the administrative district of the North Devon by:

Adding Restricted Byway No. 27 Berrynarbor

It starts on the Sterridge Valley county road 15 metres south of Footpath No.16 and follows the track that serves Middle Cock Hill Farm for 95 metres in a southerly direction, before turning south easterly just to the east of Woodlands Cottage, it then follows a track for 115 metres where it crosses the access to Woodlands House, here it then turns east, south easterly through an open area that is used as a garden, then onto an access track to re-join the county road Sterridge Valley 250 metres south of the starting point.

As the Authority has indicated that it will not be supporting the Order at the Inquiry, the case for the Order will be presented by Mr Graham Sanders. He will be expected to adhere to the following timetable as if he were the Authority.

<u>Timetable for sending in statements of case and proofs of evidence</u>

Within 8 weeks of the start date by [by 5 December 2017]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

Within 14 weeks of the start date [by 16 January 2018]

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case¹ is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

4 weeks before the date of the inquiry [by 13 March 2018]

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence).

The Authority has consulted with every local authority whose area includes the land to which the Order relates. The Devon County Council hereby order that:

- 1. For the purposes of this order the relevant date is 8th July 2016.
- 2. The County of Devon Definitive Map and Statement shall be modified as described in Part I & Part II of the Schedule and shown on the map attached to the Order.

SCHEDULE

PART I MODIFICATION OF DEFINITIVE MAP

DESCRIPTION OF WAY TO BE ADDED

Restricted Byway No. 27, Berrynarbor

This way lies in the administrative district of North Devon and in the civil parish of Berrynarbor. The Restricted Byway starts on the Sterridge Valley county road 15 metres south of Footpath No.16, Berrynarbor, at point A GR(SS 553 14577) and follows the track that serves Middle Cock Hill Farm for 95 metres in a southerly direction, before turning south easterly at point B, GR (SS 5530 4568) just to the east of Woodlands Cottage, it then follows a track for 115 metres where it is crosses the access to Woodlands House at point C, GR (SS 5536 4558) here it then turns east, south easterly through an open area that is used as a garden, then onto an access track to re-join the county road Sterridge Valley at point D, GR(SS 5544 4557) 250 metres south of point A.

The total length of the way to be added is approximately 295 metres with a width varying between about 2.6 metres and 3.6 metres over the track, and in the splayed junctions at points A and D it is about 10 metres wide. It is shown on the plan as a broken black line and small arrowheads between points A - B - C - D.


MODIFICATION OF DEFINITIVE STATEMENT VARIATION OF PARTICULARS OF WAY

Restricted Byway No. 27, Berrynarbor From: Sterridge Valley Road To: Sterridge Valley Road

This is a Restricted Byway, it starts on the Sterridge Valley county road 15 metres south of Footpath No.16 and follows the track that serves Middle Cock Hill Farm for 95 metres in a southerly direction, before turning south easterly just to the east of Woodlands Cottage, it then follows a track for 115 metres where it crosses the access to Woodlands House, here it then turns east, south easterly through an open area that is used as a garden, then onto an access track to re-join the county road Sterridge Valley 250 metres south of the starting point.

The Restricted Byway has a section of concrete surface (the privately maintained track to Middle Cockhill Farm) and the rest is unsealed with a mud, stone and bedrock surface. The total length of the way to be added is approximately 295 metres. Its width varies between 2.6 metres and 3.6 metres where defined by hedges and boundaries. In the splayed junctions at point A and D it is about 10 metres wide.
