## **GENERAL IMPORT LICENCE**

The Secretary of State by this general import licence issued under Article 4 of IAPO, authorises subject to and in accordance with the conditions set out below, the landing in England of:

[animal pathogens or carriers of animal pathogens as defined in IAPO<sup>1</sup>, excluding Specified Animal Pathogens<sup>2</sup> listed in the Specified Animal Pathogens Order 2008 as amended.<sup>3</sup>]

### Conditions attached to this licence

- It is the responsibility of the importer to ensure that the exporter provides a
  declaration confirming that the material does not contain or is not suspected to
  contain a Specified Animal Pathogen, as listed in the Specified Animal
  Pathogens Order 2008 (as amended)"<sup>4</sup>. Please read the guidance notes
  below and complete the declaration template:

- 2. The material must be for research or diagnostic purposes only. Each consignment must be accompanied by:
  - a copy of this licence;
  - commercial/shipping documents providing the name and address of consignor and consignee, type of material and quantities;
  - a signed copy of the declaration required by condition 1.
- 3. The samples must be worked on and stored in facilities working to at least ACDP Containment Level 2 (see Note 2).
- 4. The packaging must be clearly labelled to indicate the general licence number under which the material is imported. The label should also state that the material is for importation into England for laboratory use for research or diagnostic purposes.
- 5. The material must remain in its original wrapping at all times until its arrival at the destination premises.
- 6. All packages must be taken directly from the point of entry into England to the destination premises.
- 7. The consignment, or its packaging, must not be allowed to come into contact with any ruminating animals, swine, poultry or horses, or humans not intended to handle this material (see Note 3).
- 8. None of the material to which this licence relates shall be used for human consumption under any circumstances.
- 9. On completion of the testing, material may be stored for reference purposes.

  Unused material and any residues of the material and the remainder of the packaging must be either incinerated at a premises that has been approved

- for the disposal of animal by-products (see Note 9), autoclaved, or reexported (see Note 12).
- 10. If there is an outbreak of a notifiable/reportable disease in the exporting country/countries, the conditions of this licence may change. In this event you should contact the Imports Licensing Team at the address below for advice on importing pathogens from that country. - 11. If the material is subsequently to be moved to another establishment, the importer must make the recipient aware of the requirement to destroy or reexport the residues of the material (see Notes 9 and 12).
- 12. If at any time you are unable to meet the conditions of the licence, or if any unlicensed specified animal pathogen is discovered in the imported material, work must be suspended immediately and the facts reported at once to the Animal Plant Health Agency Regional Field Services Office for your area which can be found at: <a href="https://www.gov.uk/government/organisations/animal-and-plant-health-agency/about/access-and-opening">https://www.gov.uk/government/organisations/animal-and-plant-health-agency/about/access-and-opening</a> or telephone 03000 200 301.
- 13. The importer is responsible for ensuring that the person(s) sending the material to England is aware of the conditions of this licence and completes the declaration.
- 14. Any material and records relating to the material imported under this licence shall be made available if so required for inspection by the Officer of Animal and Plant Health Agency at any place nominated by him/her for such inspection. The importer or their agent shall afford all assistance necessary to such an officer to enable him/her to carry out the inspection in such a manner as they may determine.

# **NOTES**

- 1. **CAUTION:** It is the importer's responsibility to ensure that any import covered by this licence complies with terms and conditions as set out.
- 2. ACDP Containment Level 2 must be used for work with biological agents in hazard group 2. Laboratory personnel must receive suitable and sufficient information, instruction and training in working safely with agents in hazard group 2. A high standard of supervision of the work should be maintained. - 3. **Safety:** Importers are responsible for ensuring that the health and safety requirements relating to the pathogens or carriers of animal pathogens are appropriately assessed and dealt with by ensuring suitable handling, packaging and labelling. See Condition 4. This licence does not obviate the importer from their responsibility to carry out a risk assessment and implement the appropriate controls.
- 4. You must contact the Defra Pathogens Licensing Team if you wish to have in your possession in England any animal pathogen or carrier for which a licence is required under the Specified Animal Pathogens Order 2008 (see Note 10 for more details). If you already hold a specified animal pathogen or carrier for which a licence is required under Article 4 of the Specified Animal Pathogens Order 2008 and for which you do not hold a licence under that Order, you must immediately notify Defra at <a href="mailto:pathogens@defra.gsi.gov.uk">pathogens@defra.gsi.gov.uk</a> or telephone 020 7238 3153 or 6212.
- 5. This licence only applies to an animal pathogen or carrier imported into England from a European Union Member State, the Isle of Man, Guernsey, Jersey, Iceland, Liechtenstein, Norway or Switzerland. If you would like to import an animal pathogen into England from a country outside the EU, you should contact APHA at <a href="mailto:imports@apha.gsi.gov.uk">imports@apha.gsi.gov.uk</a>. If you wish to import material into Scotland, Wales or Northern Ireland you should contact the relevant Department for advice.
- 6. Nothing in this licence gives exemption from any prohibition or restriction imposed by any other legislation.
- 7. This licence is granted under animal health import legislation and gives no exemption from any prohibition, regulation or restriction imposed by any other Government Department or Agency or to Scottish Government, Welsh Government or Northern Ireland law.
- 8. Please note that while this licence is current at the time of its issue, conditions can be subject to frequent change and importers are advised to check the latest position with the Imports Licensing Team (see contact details below).
